1.5 the Campaign Finance and Public Disclosure Board and the Department of Revenue;  
1.6 appropriating money; amending Minnesota Statutes 2022, sections 10A.02, subdivision  
1.7 11b; 10A.322, subdivision 4; Minnesota Statutes 2023 Supplement, section 290.06,  
1.8 subdivision 23.
