AGENDA ITEM #1: Health and Human Services Omnibus Budget Bill (Document SC4101)

- Senator Berglin asked David Godfrey, the Health and Human Services Fiscal Analyst, to explain the spreadsheet for the bill.
- Mr. Godfrey testified on the spreadsheet.
- A quorum was present at 9:30.
- Senator Berglin also testified on the spreadsheet.
- Mr. Godfrey and Senator Berglin stood for questions.
- Mr. Godfrey testified in response to questions from Senator Cohen.
- Doug Stang, Department of Health, testified in response to a question about fees and a question from Senator Pariseau.
- Mr. Wattson testified, clarifying an issue the committee was discussing.
- Senator Metzen moved the A1 amendment. Motion carried.
- Senator Frederickson moved an oral amendment to SC4101:

-Page 8, line 36, delete "reasonable"

- Senator Frederickson's motion is adopted.
- Senator Berglin moved that SC4101 as amended be introduced as a committee bill and be recommended to pass. Motion carried.

-Page 25, lines 9 and 10, delete "\$2,000,000" and insert \$1,500,000"

- Senator Frederickson moved an oral amendment:
 - -Page 3, line 17, delete "regulate" and insert "control"
 - -Page 3, line 18, delete "environment" and insert "surroundings"
 - -Page 3, line 19, after "learn" insert "from them"
- Senator Frederickson's oral amendment was adopted.
- Karen Carlson, Department of Education, testified in response to a question from Senator Gerlach.
- Senator Gerlach moved an oral amendment:
 - -Page 21, line 24, delete "for" and insert "on"
- Senator Gerlach's oral amendment was adopted.
- Senator Hottinger moved that 05-4093 be introduced as a committee bill, recommended to pass, and be referred to the Committee on Taxes. Motion carried.
