AGENDA ITEM #1: Basic Sliding Fee

- Commissioner Kevin Goodno, Department of Human Services and Chuck Johnson, Assistant Commissioner for Children and Family Services, Department of Human Services
 - Both Commissioner Goodno and Assistant Commissioner Johnson gave an overview of the governor's budget recommendations. Those recommendations include extending the freeze on maximum rates paid for childcare assistance through June 30, 2007. Those rates will then be restricted to a general inflation rate beginning July 1, 2007.
- Ann Sessoms, Director of Transition to Economic Stability and Cherie Kotilnek, Supervisor of Childcare Assistance Programs
 - o Ms. Sessoms gave an overview of Minnesota's Childcare Assistance Program
 - o Ms. Kotilnek gave an overview of the Childcare Assistance Family Program
- Ann Kaner-Roth, Executive Director of Childcare WORKS
 Ms. Kaner-Roth gave an overview on issues of childcare. She talked about childcare as "school readiness" and as work support. Ms. Kaner-Roth urged the committee to oppose the governor's proposals.
- Tarryl Clark, Executive Director, Minnesota Community Action Association, and Joe Peterson, Executive Director of Lakes and Prairies Community Action Partnership
 - They gave an overview of childcare in Northwest Minnesota. They highlighted recent cuts and childcare center closings, while emphasizing the program "Right from the Start." Ms. Clark mentioned that childcare is a place where kids get their preschooling.
- Chad Dunkley, Minnesota Childcare Association and Executive Director of New Horizon Childcare Centers
 - Mr. Dunkley gave an overview of the Legislative Auditor's childcare reimbursement rates and Department of Human Services' Report on Cost of Children. He emphasized his opposition to cuts because families and centers are struggling to pay the bills.
- Jim Koppel, Director of Minnesota Children's Defense Fund, a non-profit children's advocacy group
 - o Mr. Koppel said that health care and childcare are key to successful families. He

said that 6,300 MFIP families quit using childcare assistance programs, and we have no idea where those children are going. Mr. Koppel posed the question: Are we really saving money when families are losing their health insurance and their childcare assistance?

- Todd Otis, President of Ready 4 K.
 - Mr. Otis urged the committee to change the nomenclature from "childcare" to "early child care and education/learning."
- Lois Engstrom, Minnesota Association for Family and Early Education (MNAFEE), a 501(c)3 organization
 - Her goal is to make quality family/early education available to all those in Minnesota. Ms. Engstrom emphasized that childcare is early education.
