Delete everything after the enacting clause and insert:

"Section 1. Minnesota Statutes 2004, section 256B.434, is amended by

adding a subdivision to read:

Subd. 4f. [RATE INCREASE EFFECTIVE JULY 1, 2005.] (a) For the

rate year beginning July 1, 2005, a 166-bed nursing facility in the city of Duluth

with reimbursement rates substantially below the Duluth average shall receive an

increase of \$25 in each case mix payment rate. The increase shall be included

in the facility's total payment rate for purposes of determining future rates under this section or any other section

this section or any other section.

(b) The commissioner shall identify savings that occur as the result of admissions to the facility described in paragraph (a) of persons transferring from another facility in Duluth that is owned by the same entity and is downsizing. Any savings identified by the commissioner are appropriated to the commissioner for the purposes of paragraph (a).

[EFFECTIVE DATE.] <u>This section is effective July 1, 2005.</u>"
