Senator Linda Berglin, Chair of the Health and Human Services Budget Division, called the twenty-eighth meeting to order at 12:45 p.m. on Thursday, April 21, 2005, in Room 15 of the State Capitol, St. Paul Minnesota.

The first bill up for consideration was S.F. 1115, authored and explained by Senator Fischbach, as follows:

S.F. 1115 (FISCHBACH): A bill for an act relating occupations; requiring plumbers to be licensed; establishing inspection requirements for new plumbing installations; allowing the commissioner to charge fees to hire staff; licensing restricted plumbing contractors; requiring rulemaking.

Senator LeClair moved that S.F. 1115 be laid over for possible inclusion in the Health and Human Services Omnibus Bill. The **MOTION PREVAILED**.

The second bill up for consideration was S.F. 1840, authored and explained by Senator Limmer, as follows:

S.F. 1840 (LIMMER): A bill for an act relating to health; providing an exception to the hospital construction moratorium.

Senate File 1840 was laid over temporarily.

The third bill up for consideration was S.F. 1204, authored and explained by Senator Kiscaden, as follows:

S.F. 1204 (KISCADEN): A bill for an act relating to health; recodifying statutes and rules relating to social work; authorizing rulemaking; providing penalties; modifying provisions relating to physical therapists; providing penalties; modifying the Psychology Practice Act; phasing out licensure as a licensed psychological practitioner; modifying dental licensure provisions; establishing fees; modifying provisions for licensed professional counselors; authorizing certain rulemaking; modifying physician review; modifying information contained on prescriptions; providing recognition for the practice of respiratory therapy in emergency situations; providing that audiologists need not obtain hearing instrument dispenser certification; providing penalties; transferring oversight authority
