Senator LeRoy A. Stumpf called the meeting to order at 10:30 a.m.

S.F. 3274 Senator Stumpf: Miscellaneous education provisions modifications.

Legislation authorizing supplemental spending on schools was approved by members. Senator Stumpf stated the division was given a budget target of \$44 million in onetime aid to school districts and charter schools. He said he would like to provide the funds on an on-going basis.

Eric Nauman walked the members through the proposal and spreadsheets showing the aid and levy changes.

Motion: Senator Skoglund put the A-11 amendment before the committee.

MOTION CARRIED.

Motion: Senator Fischbach moved to put the A-6 amendment before the members. **MOTION CARRIED.**

Motion: Senator Hann moved that on page 56 line 56.26 delete Section 123B.749. This provision in the bill would repeal a requirement for school districts to report on their financial situation before approving collective bargaining agreements.

A divison was requested. 9 nay - 7 yea --the motion did not pass.

Motion: Senator Kelley put the A-10 and A-9 amendments before the committee. **MOTION CARRIED.**

Motion: Senator Wergin moved to put the A-3 amendment before the committee. **MOTION CARRIED.**

Motion: Senator Wergin moved to put the A-2 amendment before members. There was discussion and Senator Wergin withdrew her amendment.


Motion: Senator Kelley moved to put the A-12 amendment before members. **MOTION CARRIED.**
