Senator Berglin moved S.F. 2625 as amended be passed to the floor.


Senator Day requested a roll call vote. Motion was adopted. Aye=14, Nay=8, Abstain=0

Senator Wiger explained the subcommittee report from the Subcommittee on Litigation Expenses. He testified before the committee and answered questions from members of the committee.


Frederick Knaak, Council for Senator Grace Schwab, testified before the committee and answered questions from the members of the committee.
