Bill Description

HF2917 proposes to increase the distribution of Lottery in Lieu tax from the Department of Revenue to Natural Resource

and Game & Fish funds from 72.43 percent to 97 percent. Distributions to Natural Resource and Game & Fish funds would increase, and therefore leave a decreased amount to the General Fund.

Assumptions

This analysis reflects increased resources in Natural Resource and Game & Fish funds, and reduced resources to the General Fund. Estimates are based on the November 2021 Budget Forecast. Funds imapcted are as follows: General; State Parks and Trails; Metro Parks and Trails; Local Trails Grants; MN Zoos; and Heritage Enhancement. Because spending from the impacted funds is defined in separate legislation, this fiscal note shows only increased resources and no potential spending increases.

Expenditure and/or Revenue Formula

FY23 budgeted: \$34,933,000 distribution / 72.43% = \$48,230,015 total LIL revenue

FY23 proposed: \$48,230,015 total LIL revenue x 97% = \$46,783,115 distribution

FY24-25 budgeted (per FY): \$36,204,000 distribution / 72.43% = \$49,984,813 total LIL revenue

FY24-25 proposed (per FY): \$49,984,813 total LIL revenue x 97% = \$48,485,269 distribution

Bill Description

This bill amends Minnesota Statutes 2020, 297A.94, Section 1(h) by updating the required deposit of revenues for lottery tickets in lieu of taxes to 97% from 72.43%.

This bill does not include an effective date. Therefore, by Minnesota Statute 645.02 EFFECTIVE DATE AND TIME OF LAWS, this bill is effective August 1 following its final enactment.

Assumptions

DOR currently determines the distribution of funds and makes the distribution. DOR will make the change to distribute the new amount noted in the bill. This administrative impact is minimal.

Expenditure and/or Revenue Formula

This bill may have an impact on state tax revenues. An estimate of revenue impact is not included in this fiscal note. The Department of Revenue prioritizes revenue estimate requests for bills before Tax Committee and will provide one for this bill when it is before Tax Committee.

Long-Term Fiscal Considerations

The bill does not have long term fiscal considerations.
