

1.1 Senator ..... moves to amend S.F. No. 3268 as follows:

1.2 Page 1, line 7, before "law" insert "state" and after "contrary" insert "and unless prohibited  
1.3 by federal law"

1.4 Page 1, delete lines 14 to 17 and insert:

1.5 "(1) that part of Government Lot 1, Section 1, Township 52 North, Range 11 West of  
1.6 the 4th Principal Meridian, Lake County, Minnesota, lying southerly and easterly of the  
1.7 following described lines: commencing at the Center East 1/16 Corner; thence along the  
1.8 North-South 1/16 line on an assumed bearing of North 00 degrees 46 minutes 07 seconds  
1.9 East 144.23 feet; thence North 67 degrees 30 minutes 43 seconds West 385.00 feet; thence  
1.10 North 22 degrees 29 minutes 17 seconds East 24.00 feet; thence South 67 degrees 30 minutes  
1.11 43 seconds East 385.00 feet; thence easterly a distance of 232.90 feet along a tangential  
1.12 curve concave to the North having a radius of 611.85 feet and central angle of 21 degrees  
1.13 48 minutes 36 seconds; thence South 89 degrees 19 minutes 19 seconds East 1015.67 feet;  
1.14 thence South 00 degrees 40 minutes 41 seconds West 35.00 feet; thence South 89 degrees  
1.15 19 minutes 19 seconds East 73.08 feet to the east line of said Government Lot 1 and the  
1.16 point of beginning of said line; thence North 89 degrees 19 minutes 19 seconds West 877.08  
1.17 feet; thence North 00 degrees 40 minutes 41 seconds East 11.00 feet; thence North 89  
1.18 degrees 19 minutes 19 seconds West 28.86 feet; thence South 0 degrees 51 minutes 25  
1.19 seconds West 19.82 feet to a 3/4-inch by 24-inch rebar marked "MN DNR LS 16098" (DNR  
1.20 monument); thence continuing South 00 degrees 51 minutes 25 seconds West 484.06 feet  
1.21 to a DNR monument; thence continuing South 00 degrees 51 minutes 25 seconds West 78  
1.22 feet, more or less to the shore of Lake Superior and there terminating; containing 14.5 acres,  
1.23 more or less (parcel identification number 23-7600-01415);

1.24 (2) that part of Government Lot 3, Section 6, Township 52 North, Range 10 West of the  
1.25 Fourth Principal Meridian, described as follows: commencing at the West Quarter corner  
1.26 of said Section 6 (Northwest corner of said Government Lot 3); thence North 88 degrees  
1.27 43 minutes 09 seconds East along the North line of said Government Lot 3 a distance of  
1.28 485.19 feet; thence South 00 degrees 20 minutes 34 seconds East a distance of 16 feet, more  
1.29 or less, to the South line of the Northerly 16 feet of said Government Lot 3, being the point  
1.30 of beginning of the parcel described herein; thence continuing South 00 degrees 20 minutes  
1.31 34 seconds East a distance of 584 feet, more or less, to a line lying within 600 feet and South  
1.32 of the North boundary of said Government 3; thence Westerly, along said line, to the West  
1.33 line of said Government Lot 3; thence Northerly, along the West line of the said Government  
1.34 Lot 3 to the South line of the Northerly 16 feet of said Government Lot 3; thence Easterly

2.1 along the South line of the Northerly 16 feet of said Government Lot 3 to the point of  
2.2 beginning; except minerals (parcel identification number 23-7600-06605);

2.3 (3) together with that part of Government Lot 3, Section 6, Township 52 North, Range  
2.4 10 West of the 4th Principal Meridian, Lake County, Minnesota lying west of the following  
2.5 described line: commencing at the west quarter corner of said Section 6 (Northwest Corner  
2.6 of said Government Lot 3); thence North 88 degrees 43 minutes 09 seconds East along the  
2.7 north line of said Government Lot 3 a distance of 485.19 feet to the point of beginning of  
2.8 said line; thence South 00 degrees 20 minutes 34 seconds East a distance of 766.64 feet;  
2.9 thence South 54 degrees 38 minutes 48 seconds West a distance of 23 5 feet, more or less,  
2.10 to the shore of Lake Superior, and there terminating, except that part lying within 600 feet  
2.11 and South of the North boundary of said Government Lot 3; containing 2.4 acres, more or  
2.12 less (parcel identification number 23-7600-06607); and

2.13 (4) that part of Government Lot 3, Section 6, Township 52 North, Range 10 West, of  
2.14 the Fourth Principal Meridian, described as follows: commencing at the west quarter corner  
2.15 of said Section 6 (northwest corner of said Government Lot 3); thence North 88 degrees 43  
2.16 minutes 09 seconds East along the north line of said Government Lot 3 a distance of 485.19  
2.17 feet; thence South 00 degrees 20 minutes 34 seconds East a distance of 766.64 feet, to a  
2.18 5/8-foot rebar marked "RLS No. 16089", also being the point of beginning; thence South  
2.19 25 degrees 10 minutes 17 seconds East a distance of 51.74 feet to a 3/4-inch by 12-inch  
2.20 rebar marked "MN DNR LS 16098" (DNR monument); thence South 30 degrees 09 minutes  
2.21 12 seconds East a distance of 583.16 feet to a DNR monument; thence South 88 degrees  
2.22 01 minute 03 seconds West a distance of 124.04 feet to a DNR monument; thence South  
2.23 07 degrees 58 minutes 29 seconds East a distance of 517.23 feet to a DNR monument;  
2.24 thence continuing South 07 degrees 58 minutes 29 seconds East a distance of 76 feet, more  
2.25 or less, to the shoreline of Lake Superior; thence northwesterly, northerly, northeasterly and  
2.26 northwesterly a distance of 1390 feet, more or less, along said shoreline to point which bears  
2.27 South 54 degrees 38 minutes 48 seconds West from the point of beginning; thence North  
2.28 54 degrees 38 minutes 48 seconds East a distance of 25 feet, more or less, to a DNR  
2.29 monument; thence continuing North 54 degrees 38 minutes 48 seconds East a distance of  
2.30 210.00 feet to the point of beginning and there terminating (parcel identification number  
2.31 23-7600-06611)."
