S.F. 2848: Senator Housley: Promotion of importance and recruitment of peace officers appropriation.

Senator Housley presented SF 2848.

A quorum was noted at 8:34 A.M.

Senator Housley presented the A2 Amendment.

Senator Ingebrightsen moved the A2 Amendment.

Senator Ingebrightsen moved an oral amendment to the A2 Amendment as follows:

Line 1.9: Delete "money" and insert "appropriation".

Senator Ingebrightsen renewed motion. On a voice vote, the motion prevailed and THE ORAL AMENDMENT TO THE AMENDMED WAS INCORPORATED AND THE A2 AMENDMENT, AS AMENDED, WAS ADOPTED.

Senator Marty moved the A4 Amendment.

Senator Rosen recessed the committee at 8:37 A.M.

Senator Rosen reconveded the committee at 8:45 A.M.

Senator Ingebrightsen moved an oral amendment to the A4 Amendemnt as follows:

Line 1.4: Delete "2,000,000" and insert "\$1,000,000".

Senator Marty requested a roll call vote.

Senator Ingebrightsen withdrew the oral amendment to the A4 Amendment.

Senator Benson moved an oral amendment to the A4 Amendment as follows:

"Page 1, delete Line 2.

Page 1, after Section 1, insert Section 2.

Page 1, Line 4: Delete "2,000,000" and insert "\$1,000,000".

Page 1, Line 10: After the period, insert "This is a one time appropriation."

Instruct staff to amend the title accordingly."

A roll call vote was requested. The results were as follows:

Page 1, Line 7: After the period, insert "This is a one time appropriation.""
