Senator Julie A. Rosen called the meeting to order at 8:34 A.M., on Monday, April 4, 2022 in Room 1100 of the Minnesota Senate Building. A quorum was present.

S.F. 4062: Senator Ingebrihtsen: Environment and natural resources appropriations.

Senator Ingebrihtsen moved the A17 Amendment.

Senator Marty moved an oral amendment to the A17 Amendment as follows:

"Strike lines 1.2 and 1.3 and insert "Page 67, delete lines 17-26".

Senator Marty renewed motion to amend the A17 Amendment. On a voice vote, the motion did not prevail.

Senator Ingebrihtsen renewed the motion to adopt the A17 Amendment. On a voice vote, the motion prevailed and THE A17 AMENDMENT WAS ADOPTED.
