Senator Julie A. Rosen called the meeting to order at 8:37 A.M. on April 26, 2022 in Room 1200 of the Minnesota Senate Building. A quorum was present.

S.F. 3510: Senator Tomassoni: Higher education supplemental appropriations.

Senator Rarick spoke to SF 3510.

Senator Ingebrihtsen moved the A23 Amendment.

Senator Tomassoni spoke to SF 3510, as amended.

Senator Ingebrihtsen renewed motion to adopt the A23 Amendment. On a voice vote, **THE MOTION PREVAILED AND THE A23 AMENDMENT WAS ADOPTED.**

Senator Ingebrihtsen moved that S.F. 3510, as amended, be recommended to pass. - **MOTION PREVAILED.**

S.F. 3249: Senator Draheim: Mental health provider supervision grant program creation; Adult mental health initiatives modification.

Senator Draheim presented SF 3249.

Senator Benson moved the A22 Amendment. Discussion.

Senator Marty moved the A27 Amendment. Discussion.

Senator Marty renewed motion to adopt the A27 Amendment. On a voice vote, the motion did not prevail and the A27 Amendment was not adopted.

Senator Kent moved the A24 Amendment. A roll call vote was requested. The results were as follows:
