Senator Julie A. Rosen called the meeting to order at 8:38 A.M. on May 19, 2022 in Room 1200 of the Minnesota Senate Building.

H.F. 4670: Senator Anderson: Claims settlement appropriation.

Senator Bruce Anderson presented HF 4670.

A quorum was noted at 8:44 A.M.

Senator Marty moved the A22 Amendment. Amendment withdrawn.

Senator Ingebrigtsen moved that H.F. 4670, be recommended to pass. - **MOTION PREVAILED.**

H.F. 778: Senator Chamberlain: Sports wagering commission establishment; regulation and taxation of sports wagering authorization.

Senator Benson moved the A22-0482 Amendment. On a voice vote, the motion prevailed and THE A22-0482 AMENDMENT WAS ADOPTED.
