

It is with sincere passion that I am pleased to submit my application for the Board of Animal Health Livestock Producer position. As a young farmer, I have a determination for ensuring that the state of Minnesota is a leader in animal care, health, and overall well-being. My background specifically provides the board with knowledge about multiple areas of the production animal industry.

After receiving a degree in Animal Science from North Dakota State University, I served the turkey industry as Ag Program Specialist and Membership Coordinator for the Minnesota Turkey Growers Association. In that role, I strived to not only promote the industry, but to specifically support our farmers as they worked to provide the healthiest and safest supply of turkey products in the world. My job included working with farmers, educating the public in such realms as community events and the State Fair, and reaching out to youth through school visits.

In the spring of 2017, my husband and I officially became the sixth generation on the farm and have already made major improvements to our farm that ensure the health and safety of our birds. We look forward to continuing to improve our operation and hope to pass on the farm to the seventh generation.

Livestock production is in my blood. As a member of the Board of Animal Health, I will work to ensure that farmers have the support needed to provide the best living environment for their animals as possible. As our industry changes, so do our practices that ensure animal health. I believe that it is crucial for the Board of Animal Health to have members that are currently producing livestock and have a vision for the future of livestock production.
