Dear Chair Westrom and members of the committee:

On behalf of Minnesota Farmers Union (MFU), I write to share our strong support for your bill to help K12 agriculture programs introduce students to meat cutting (SF3481) and for Sen. Rarick's bill to provide training grants to meat and poultry processors (SF3320). The bottleneck in processing continues to be a challenge for our family farmer members as they work to expand their operations and meet local demand. These investments will help local and regional processors attract and retain employees and support family farmers.

- **Meat cutting grants for K12 career and technical programs (SF3481)** will compliment existing vocational programs, like small engines, welding, and construction, in introducing secondary students to meat processing. Much like in agriculture more broadly, many processors are approaching retirement and thinking about the generational transition of their businesses. This investment will not only help address a workforce shortage in the industry, but also inspire a next generation of small business owners who will take over existing plants.

Building on a successful pilot at West Central Area schools, this new competitive grant program will help secondary schools purchase supplies and equipment, do limited renovations, and gain professional development needed to stand up meat cutting courses. This investment is well-timed, because secondary schools will be able to rely on Central Lakes and Ridgewater Colleges—both of which are starting meat cutting programs in fall of 2022—for training educators. Secondary courses will also provide a pathway for students to enroll in the college programs.

- **Processor training grants (SF3320)** will help small processors upskill and retain current employees. This investment is similarly well-timed, because both colleges with meat processing training programs set to start in the fall are being designed in close partnership with industry and will have flexible options for customized training. Providing support for processors or their employees to attend trainings at these colleges or other institutions could help those businesses up their inspection status, add new species, or execute a generational transition. All of these actions will serve local farmers well.

Finally, it is important to note that this is not the only investment needed to support small processors. We also strongly support direct support for Central Lakes and Ridgewater, investing the AGRI Value Added program to expand processing capacity, and helping processors with worker recruitment and retention. Each is an important piece of rebuilding an industry that farmers rely on to get their products to market.

Thank you to your committee for your strong support of local processing. We believe these investments are central to building a food system that is more distributed, fair, and secure.
