

S.F. No. 3380 – Safe Schools Revenue

Section 1. Safe Schools Revenue.

Subdivision 1. Safe schools revenue. Increases safe schools revenue in fiscal year 2023 for a district to \$44 multiplied by the district’s adjusted pupil units for the school year or \$20,000, whichever is greater. Increases safe schools revenue in fiscal year 2024 and later for a district to \$44 multiplied by the district’s adjusted pupil units for the school year or \$33,000, whichever is greater.

Subdivision 2. Safe schools levy. States that a district’s safe school levy for fiscal year 2023 and later is equal to \$36 multiplied by the district’s adjusted pupil units for the school year.

Subdivision 3. Safe schools aid. States that a district’s safe schools aid is equal to its safe schools revenue minus its safe schools levy multiplied by the ratio of the actual amount levied to the permitted levy.

Subdivision 4. Cooperative safe schools revenue. (a) States that for fiscal year 2023 and later, a cooperative safe schools revenue for a school district that is a member of a cooperative unit equals the district’s adjusted pupil units for the school year times \$18. Requires that revenue raised under this subdivision be transferred to the cooperative unit. Defines “cooperative unit.”

(b) States that for fiscal year 2023 and later, a school district that is a member of an intermediate district may not exceed \$15 times the adjusted pupil units of the member district. This authority is in addition to the authority under subdivision 2.

(c) States that for fiscal year 2023 and later, a cooperative safe schools aid for a school district that is a member of a cooperative unit is equal to its cooperative safe schools revenue minus its cooperative safe schools levy multiplied by the ratio of the actual amount levied to the permitted levy.

Subdivision 5. Safe schools aid for charter schools. States that a charter school’s safe school aid for fiscal year 2023 and later is equal to \$44 multiplied by the district’s adjusted pupil units for the school year.

Subdivision 6. Safe schools aid for nonpublic schools. States that a nonpublic school's safe school aid for fiscal year 2023 and later is equal to \$44 multiplied by the enrollment number for the school year. Defines "nonpublic schools."

Subdivision 7. Safe schools aid for American Indian tribal contract or grant schools. States that an American Indian tribal contract or grant school's safe school aid for fiscal year 2023 and later is equal to \$44 multiplied by the enrollment number for the school year. Defines "American Indian tribal contract or grant school."

Subdivision 8. Uses of safe schools revenue. Requires that safe schools revenue under this section be reserved and used for the specific purposes listed. Adds as allowable uses school-linked mental health services delivered by telemedicine and to pay for the costs of enhancing cybersecurity in the district's information system.

Effective Date. Makes the section effective the day following final enactment.

Section 2. Appropriation.

Subdivision 1. Department of Education. Appropriates money from the general fund to the Department of Education for the fiscal years designated.

Subdivision 2. Safe schools revenue. Appropriates \$17,262,000 for fiscal year 2023.
