### **Bill Description**

This bill modifies requirements for interpreters in schools to include a new ALS license category called Certified Deaf Interpreter (CDI).

#### **Assumptions**

No administrative cost to MDE as activities outlined in proposal would be the responsibility of current Deaf/Hard of Hearing specialist.

The number of additional Certified Deaf Interpreters (CDIs) needed by school districts is estimated to be up to 10 interpreters statewide. It is assumed that the additional CDIs will be new positions, and are not replacing other current district employees. Based on a three year average, the average cost per CDI is \$50,000 annually (salary and benefits). If 10 additional CDIs are hired, the annual cost would be \$500,000. State aid entitlement for these positions is paid at roughly 61 percent of total salary and benefit costs. It is assumed that districts will fill these positions starting in FY 2022. Special education aid would begin in FY 2023.

It is assumed that the salary and benefit costs for these positions will be ongoing.

# **Expenditure and/or Revenue Formula**

10 CDIs hired in FY 22 (10 \* \$50,000 = \$500,000)

State aid entitlement = 61% of salary and benefit costs (\$500,000 \* .61 = \$305,000)

Based on this entitlement change, the change in special education aid appropriation under the current payment schedule (87.66% current and 12.34% final) is as follows:
