1.8 average daily membership of eligible English learners enrolled in the district during the
1.9 current fiscal year;

1.10 (2) \$250 times the English learner pupil units under section 126C.05, subdivision 17;

1.12 (3) the district's English learner cross subsidy aid. A district's English learner cross
1.13 subsidy aid under paragraph (b) equals:

1.14 (i) 25 percent of the district's English learner cross subsidy for fiscal year 2023;

1.15 (ii) 50 percent of the district's English learner cross subsidy for fiscal year 2024;

1.16 (iii) 75 percent of the district's English learner cross subsidy for fiscal year 2025; and

1.17 (iv) 100 percent of the district's English learner cross subsidy for fiscal years 2026 and
1.18 later.

1.19 (b) A district's English learner cross subsidy aid equals the greater of zero or the difference
1.20 between the district's expenditure for qualifying English learner services for the second
1.21 previous year and the district's English learner revenue for the second previous year.

1.23 the school year in which the pupil attains the state cutoff score on a commissioner-provided

2.1 (2) English learner revenue under section 124D.65, subdivision 5; ~~plus~~

2.4 "Sec. 12. **ADDITIONAL GENERAL EDUCATION AID; ENGLISH LEARNER**
2.5 **AID; APPROPRIATION.**

2.6 \$47,570,000 in fiscal year 2023 is appropriated from the general fund to the Department
2.7 of Education for additional English learner general education aid."
