

1.1 Senator moves to amend the delete-everything amendment (SCS4113A-1)
1.2 to S.F. No. 4113 as follows:

1.3 Page 6, after line 28, insert:

1.4 "Sec. 7. Minnesota Statutes 2020, section 124D.4531, subdivision 1, is amended to read:

1.5 Subdivision 1. **Career and technical revenue.** (a) A district with a career and technical
1.6 program approved under this section for the fiscal year in which the levy is certified is
1.7 eligible for career and technical revenue equal to ~~35 percent of the~~ approved expenditures
1.8 in the fiscal year in which the levy is certified ~~for~~, times 35 percent for levies certified in
1.9 2022, 50 percent for levies certified in 2023, and 65 percent for levies certified in 2024 and
1.10 later. Approved expenditures include the following:

1.11 (1) salaries paid to essential, licensed personnel providing direct instructional services
1.12 to students in that fiscal year, including extended contracts, for services rendered in the
1.13 district's approved career and technical education programs, excluding salaries reimbursed
1.14 by another school district under clause (2);

1.15 (2) amounts paid to another Minnesota school district for salaries of essential, licensed
1.16 personnel providing direct instructional services to students in that fiscal year for services
1.17 rendered in the district's approved career and technical education programs;

1.18 (3) contracted services provided by a public or private agency other than a Minnesota
1.19 school district or cooperative center under chapter 123A or 136D;

1.20 (4) necessary travel between instructional sites by licensed career and technical education
1.21 personnel, and student travel, as directed by the school district, between an instructional
1.22 site and a job placement site in a state approved work-based learning program;

1.23 (5) necessary travel by licensed career and technical education personnel for ~~vocational~~
1.24 career and technical student organization activities held within the state for instructional
1.25 purposes;

1.26 (6) curriculum development activities that are part of a five-year plan for improvement
1.27 based on program assessment;

1.28 (7) necessary travel by licensed career and technical education personnel for noncollegiate
1.29 credit-bearing professional development; and

1.30 (8) specialized ~~vocational~~ career and technical instructional supplies.

1.31 (b) The district must recognize the full amount of this levy as revenue for the fiscal year
1.32 in which it is certified.

2.1 ~~(e) The amount of the revenue calculated under this subdivision may not exceed~~
 2.2 ~~\$17,850,000 for taxes payable in 2012, \$15,520,000 for taxes payable in 2013, and~~
 2.3 ~~\$20,657,000 for taxes payable in 2014.~~

2.4 ~~(d) If the estimated revenue exceeds the amount in paragraph (c), the commissioner must~~
 2.5 ~~reduce the percentage in paragraph (a) until the estimated revenue no longer exceeds the~~

 2.11 ~~one or the ratio of its adjusted net tax capacity per adjusted pupil unit in the fiscal year in~~
 2.12 ~~which the levy is certified to the career and technical revenue equalizing factor. The career~~
 2.13 ~~and technical revenue equalizing factor for fiscal year 2014 equals \$7,612.~~

2.14 ~~(b) For fiscal year 2015 and later, A district may levy an amount not more than the~~
 2.15 ~~product of its career and technical revenue times the lesser of one or the ratio of its adjusted~~

 2.24 ~~If the district levy is less than the permitted levy, the district's career and technical aid shall~~
 2.25 ~~be reduced proportionately.~~

2.30 Subd. 9. **Career and technical aid** For career and technical aid under Minnesota Statutes,
 2.31 section 124D.4531, subdivision 1b:

3.14 (b) To the extent practicable, the commissioner must award grants equitably among
 3.15 greater Minnesota and the seven-county metropolitan area.

3.16 (c) This is a onetime appropriation and is available until June 30, 2024."

3.18 "Sec. 13. **REPEALER.**

3.19 Minnesota Statutes 2020, section 124D.4531, subdivision 3a, is repealed."
