1.6 Section 1. Minnesota Statutes 2020, section 3.732, subdivision 1, is amended to read:

1.7 Subdivision 1. **Definitions.** As used in this section and section 3.736 the terms defined  
1.8 in this section have the meanings given them.

1.9 (1) "State" includes each of the departments, boards, agencies, commissions, courts, and  
1.10 officers in the executive, legislative, and judicial branches of the state of Minnesota and  
1.11 includes but is not limited to the Housing Finance Agency, the Minnesota Office of Higher  
1.12 Education, the ~~Higher~~ Health and Education Facilities Authority, the Health Technology  
1.13 Advisory Committee, the Armory Building Commission, the Zoological Board, the  
1.14 Department of Iron Range Resources and Rehabilitation, the Minnesota Historical Society,  
1.15 the State Agricultural Society, the University of Minnesota, the Minnesota State Colleges  
1.16 and Universities, state hospitals, and state penal institutions. It does not include a city, town,  
1.17 county, school district, or other local governmental body corporate and politic.

1.18 (2) "Employee of the state" means all present or former officers, members, directors, or

1.20 disposal unit approved by the commissioner of public safety and employed by a municipality  
1.21 defined in section 466.01 when engaged in the disposal or neutralization of bombs or other  
1.22 similar hazardous explosives, as defined in section 299C.063, outside the jurisdiction of the  
1.23 municipality but within the state, or persons acting on behalf of the state in an official  
1.24 capacity, temporarily or permanently, with or without compensation. It does not include  
1.25 either an independent contractor except, for purposes of this section and section 3.736 only,  
1.26 a guardian ad litem acting under court appointment, or members of the Minnesota National  
1.27 Guard while engaged in training or duty under United States Code, title 10, or title 32,  
1.28 section 316, 502, 503, 504, or 505, as amended through December 31, 1983. Notwithstanding

4.2 **136A.25 CREATION.**

4.3 A state agency known as the Minnesota ~~Higher~~ Health and Education Facilities Authority  
4.4 is hereby created.

4.5 Sec. 4. Minnesota Statutes 2020, section 136A.26, is amended to read:

4.6 **136A.26 MEMBERSHIPS; OFFICERS; COMPENSATION; REMOVAL.**

4.7 Subdivision 1. **Membership.** The Minnesota ~~Higher~~ Health and Education Facilities

5.3 It is hereby declared that for the benefit of the people of the state, the increase of their  
5.4 commerce, welfare and prosperity and the improvement of their health and living conditions  
5.5 it is essential that health care organizations within the state be provided with appropriate  
5.6 additional means to establish, acquire, construct, improve, and expand health care facilities  
5.7 in furtherance of their purposes; that this and future generations of youth be given the fullest  
5.8 opportunity to learn and to develop their intellectual and mental capacities; ~~that it is essential~~  
5.9 that institutions of higher education within the state be provided with appropriate additional  
5.10 means to assist such youth in achieving the required levels of learning and development of  
5.11 their intellectual and mental capacities; and health care organizations and institutions  
5.12 of higher education be enabled to refinance outstanding indebtedness incurred to provide

 6.25 customarily deemed to result in a current operating charge.

6.26 Subd. 4. **Cost.** "Cost," as applied to a project or any portion thereof financed under the  
 6.27 provisions of sections 136A.25 to 136A.42, means all or any part of the cost of construction,  
 6.28 acquisition, alteration, enlargement, reconstruction and remodeling of a project including  
 6.29 all lands, structures, real or personal property, rights, rights-of-way, franchises, easements  
 6.30 and interests acquired or used for or in connection with a project, the cost of demolishing
