1.8 Subdivision 1. Application; birth record. A subject of a birth record who is medical
1.9 assistance eligible according to chapter 256B, and who has been treated for a substance use
1.10 disorder within the past 12 months, may apply to the state registrar or a local issuance office
1.11 for a certified birth record according to this section. The state registrar or local issuance
1.12 office shall issue a certified birth record, or statement of no vital record found, to a subject
1.13 of a birth record who submits:

1.14 (1) a completed application signed by the subject of the birth record;

1.15 (2) a statement of eligibility that complies with the requirements in subdivision 2 from
1.16 an employee of a treatment provider licensed under chapter 245G that receives public
1.17 funding to provide services to people with substance use; and

1.18 (3) identification in the form of:

1.19 (i) a document of identity listed in Minnesota Rules, part 4601.2600, subpart 8, or, at
1.20 the discretion of the state registrar or local issuance office, Minnesota Rules, part 4601.2600,
1.21 subpart 9;

1.22 (ii) a statement that complies with Minnesota Rules, part 4601.2600, subparts 6 and 7;
1.23 or

1.24 (iii) a statement of identity provided by the employee of a licensed treatment provider
1.25 that receives public funding to provide services to people with substance use disorders who
1.26 verified eligibility. The statement must comply with Minnesota Rules, part 4601.2600,
1.27 subpart 7.

1.28 Subd. 2. Statement of eligibility. A statement of eligibility must be from an employee
1.29 of a treatment provider licensed under chapter 245G that receives public funding to provide
1.30 services to people with substance use disorders. The statement of eligibility must verify the
1.31 subject of the birth record is medical assistance eligible according to chapter 256B and has

2.1 been treated for a substance use disorder within the last 12 months. The statement of
 2.2 eligibility must also include:

2.3 (1) the employee's first name, middle name if any, and last name; home or business
 2.4 address and telephone number if any; and e-mail address if any;

2.5 (2) the name of the licensed treatment provider that receives public funding to provide
 2.6 services to people with substance use disorders that employs the person making the eligibility
 2.7 statement;

2.8 (3) the first name, middle name if any, and last name of the subject of the birth record;

2.9 (4) a copy of the employee's employment identification, or verification of employment,
 2.10 linking the employee to the licensed treatment provider that provided treatment; and

2.11 (5) a statement specifying the relationship of the employee providing the eligibility
 2.12 statement to the subject of the birth record.

2.13 Subd. 3. **Data practices.** Data listed under subdivision 1, clauses (2) and (3), are private
 2.14 data on individuals."

- 3.14 254B.12, subdivision 5, for services provided between January 1, 2023, and March 31,
- 3.15 2025, must be used to increase compensation-related costs for employees directly employed
- 3.16 by the program on or after January 1, 2023. For the purposes of this paragraph,
- 3.17 "compensation-related costs" include:
- 3.18 (1) wages and salaries;
- 3.19 (2) the employer's share of FICA taxes, Medicare taxes, state and federal unemployment
- 3.20 taxes, workers' compensation, and mileage reimbursement;
- 3.21 (3) the employer's paid share of health and dental insurance, life insurance, disability
- 3.22 insurance, long-term care insurance, uniform allowance, pensions, and contributions to

- 3.24 (4) benefits that address direct support professional workforce needs, above and beyond
- 3.25 benefits offered to employees prior to January 1, 2023, including retention and recruitment
- 3.26 bonuses and tuition reimbursement.
- 3.27 (b) Compensation-related costs for persons employed in the central office of a corporation
- 3.28 or entity that has an ownership interest in the provider or exercises control over the provider,
- 3.29 or for persons paid by the provider under a management contract, do not count toward the
- 3.30 80 percent requirement under this subdivision.

4.1 (c) A provider agency or individual provider that receives a rate subject to the
 4.2 requirements of this subdivision shall prepare, and upon request submit to the commissioner,
 4.3 a distribution plan that specifies the amount of money the provider expects to receive that
 4.4 is subject to the requirements of this subdivision, including how that money was or will be
 4.5 distributed to increase compensation-related costs for employees. Within 60 days of final
 4.6 implementation of a rate adjustment subject to the requirements of this subdivision, the
 4.7 provider must post the distribution plan. The distribution plan must remain posted for a
 4.8 period of at least six months in an area of the provider's operation to which all direct support
 4.9 professionals have access.

4.10 **EFFECTIVE DATE.** This section is effective January 1, 2023, or upon federal approval,
 4.11 whichever is later. The commissioner of human services shall inform the revisor of statutes
 4.12 when federal approval is obtained.

4.15 Subd. 5. **Substance use disorder services provider rate increase effective January**
 4.16 **1, 2023.** For substance use disorder services listed in sections 254B.05, subdivision 5, and
 4.17 256B.0759, subdivision 6, provided on or after January 1, 2023, payment rates shall be
 4.18 increased by ten percent over the rates in effect on December 31, 2022."

4.23 (a) Applicants and license holders for chemical dependency residential and nonresidential
 4.24 programs must demonstrate compliance with HIV minimum standards ~~prior to~~ before their
 4.25 application ~~being~~ is complete. The HIV minimum standards contained in the HIV-1
 4.26 Guidelines for chemical dependency treatment and care programs in Minnesota are not
 4.27 subject to rulemaking.

4.28 (b) ~~Ninety days after April 29, 1992,~~ The applicant or license holder shall orient all
 4.29 chemical dependency treatment staff and clients to the HIV minimum standards. Thereafter,
 4.30 orientation shall be provided to all staff and clients, within 72 hours of employment or
 4.31 admission to the program. In-service training shall be provided to all staff on at least an
 4.32 annual basis and the license holder shall maintain records of training and attendance.
