

Urgent support needed to maintain shelters and homelessness support services



Worsened by the COVID-19 crisis, the number of people experiencing homelessness continues to rise. In the Twin Cities East Metro, Ramsey County, the City of Saint Paul, State of Minnesota, and many nonprofit and community partners have worked quickly to provide and sustain shelter and support services with **MORE THAN \$43 MILLION** in COVID-19 emergency funds. This one-time funding will expire this spring while the number of people experiencing homelessness and in need of shelter continues to grow. Help us maintain these critical resources by providing funding of \$72.5 million over the next five years.

NEW EMERGENCY SHELTERS CREATED TO ADDRESS SURGING NEEDS

To support expanded shelter needs throughout the COVID-19 pandemic, since March 2020, Ramsey County invested more than \$35 million of property tax levy, CARES Act and American Rescue Plan Act (ARPA) funds to add shelter capacity and supportive services. The City of Saint Paul deployed \$8 million for operating costs of the Freedom House day shelter.

Beginning in April 2020, Ramsey County established several emergency COVID shelters



that served, at their peak, more than 450 people and families experiencing homelessness. Through hotel lease programs; temporary shelters at Bethesda Hospital, Luther Seminary and the Provincial House; and daytime services at Freedom House, the county and its partners were able to meet the growing need for emergency shelter with in-house support services.

Funds are needed to address the ongoing crisis before 450 beds for men, women and children are no longer available.

EMERGENCY RESPONSE IS WORKING, BUT SUSTAINED SUPPORT IS NEEDED

Ramsey County and the City of Saint Paul are investing \$74 million in long-term housing affordability, but it will be three to five years before new units are available. During this time, people experiencing homelessness need access to emergency shelter and services.

An investment of \$14.5 million annually over five years, or a total of \$72.5 million, will help our community maintain emergency services and meet the total demand.

Continued operation of a day service shelter, providing supportive services to 175 individuals per day
