1	S.F. 3470, section 1 (Senjem)	Requires funds appropriated under Safe Harbor to be used for authorized activities
2-6, 10	S.F. 4095, sections 1-3 Section 4, revised Sections 5-6 (Hoffman)	Modifies family assets for independence program
7-9, 14	S.F. 3263, selected provisions as amended (Dibble)	Updates Homeless Youth Act to include authorized use of grant funds and adds provider improvement grant program; updates a report date
11-12	S.F. 3278 (Hoffman)	Allows agencies to contact MFIP participants by phone or in writing; modifies income calculation for public assistance programs
13	S.F. 3644 (Hoffman)	Allows welfare agencies to use data to monitor eligibility for public assistance programs
15	S.F. 3115, revised (Rarick)	Direction to commissioner: consult with stakeholders on efforts to reduce paperwork in child protection cases

27-32	S.F. 3010, sections 1-4, 6 (Nelson)	Makes technical changes to statute governing coordinated care through behavioral health homes
40	S.F. 3165, as amended (Hoffman)	Repeals Alcohol and Other Drug Abuse Advisory Council and the Chemical Dependency Continuum of Care Pilot Project

1, 6, 11, 13 (para (r)), and 19-21	SF 3165, as amended (Hoffman)	CS-01 – CSA technical corrections and repeal of obsolete provisions
2-4	New (Abeler)	Permits ICF/DD capacity in a single-family home to increase from 6 to 8; permits certain group home capacity to increase from 4 or 5 to 5 or 6.
5 and 9	SF 2974, sec. 1 and 2 (Abeler)	Modifies requirements and state agency hearings procedures regarding basic support service terminations by 245D licensed providers.
7	SF 3165, as amended (Hoffman)	CS-08 – Culture of safety participant protections and data sharing
8 and 13	New (Abeler)	Requires contract between a local agency and a private agency to include provisions related to performance evaluations of individual case managers
10, 23 and 25	SF 3165, as amended (Hoffman)	CS-02 – Telehealth clean-up
13 (paras (d) and (f))	SF 3389 (Fateh)	extends options related to MnCHOICES assessments to providers of customized living services under BI and CADI that are currently offered to EW providers
14 and 15	SF 3165, as amended (Hoffman)	CS-09 EIDBI policy modifications
16	SF 3128 (Hoffman)	Permits additional time-limited cosigned lease arrangements between a service provider, a service recipient, and a service recipient’s landlord in community living settings.
17	SF 3165, as amended (Hoffman)	Clarifies “excluded time” for the purposes of determining the county of financial responsibility for the provision of certain services
18	SF 1468, modified (Draheim)	modifies an existing housing support moratorium exception by permitting the supportive housing units to be developed in additional metropolitan counties
22	SF 3165, as amended (Hoffman)	CS-10 – ABLE account federal conformity
24	SF 3128, revised (Hoffman)	Permits 6 or more hours of HIS with training to be billed in one-hour units.

1-2	SF 2968 (Utke)	Removes CRS licensing requirements under chapter 245A related to alternative overnight supervision and the use of alternative overnight supervision technology.
3-5	SF 3128 (Hoffman)	modifies background studies and home and community-based services standard to permit the provision of out-of-home respite to children in unlicensed settings.
