"Sec. 17. Minnesota Statutes 2020, section 256B.4911, subdivision 4, is amended to read:

- Subd. 4. **Budget exception for persons leaving institutions and crisis residential settings.** (a) The commissioner must establish an institutional and crisis bed consumer-directed community supports budget exception process in the home and community-based services waivers under sections 256B.092 and 256B.49. This budget exception process must be available for any individual who:
- (1) is not offered available and appropriate services within 60 days since approval for discharge from the individual's current institutional setting; and
- (2) requires services that are more expensive than appropriate services provided in a noninstitutional setting using the consumer-directed community supports option.
- (b) Institutional settings for purposes of this exception paragraph (a) include intermediate care facilities for persons with developmental disabilities, nursing facilities, acute care hospitals, Anoka Metro Regional Treatment Center, Minnesota Security Hospital, and crisis beds.
- (c) The budget exception <u>under paragraph</u> (a) shall be renewed each year as necessary <u>and consistent with the individual's needs, and must be limited to no more than the amount of appropriate services provided in a noninstitutional setting as determined by the lead agency managing the individual's home and community-based services waiver. The lead agency must notify the <u>Department of Human Services commissioner</u> of the budget exception.</u>
- (d) Consistent with informed choice and informed decision making, the commissioner must establish in the home and community-based services waivers under sections 256B.092 and 256B.49, a consumer-directed community supports budget exception process for individuals living in licensed community residential settings whose cost of residential services may otherwise exceed their available consumer-directed community supports budget. The budget exception process must be available to any individual living in licensed community residential settings.
- (e) The budget exceptions under paragraph (d) shall be renewed each year as necessary and consistent with the individual's needs, and must be limited to no more than the cost of the community residential services previously authorized for the individual. The lead agency must notify the commissioner of the budget exception.
