1.4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.5 Section 1. **APPROPRIATION; HUMAN SERVICES FORECAST ADJUSTMENT.**

1.6 The dollar amounts shown in the columns marked "Appropriations" are added to or, if

1.7 shown in parentheses, are subtracted from the appropriations in Laws 2021, First Special

1.8 Session chapter 7, article 16, from the general fund or any fund named to the Department

1.9 of Human Services for the purposes specified in this article, to be available for the fiscal

1.10 year indicated for each purpose. The figures "2022" and "2023" used in this article mean

1.11 that the appropriations listed under them are available for the fiscal years ending June 30,

1.12 2022, or June 30, 2023, respectively. "The first year" is fiscal year 2022. "The second year"

1.13 is fiscal year 2023. "The biennium" is fiscal years 2022 and 2023.
