Dear Governor Walz and Lieutenant Governor Flanagan:

My name is Terri Thao and I am writing to request reappointment to a second term on the board of the Minnesota Housing Finance Agency. I currently work as a program director for local non-profit intermediary Nexus Community Partners where I run the Boards and Commissions Leadership Institute (BCLI) whose purpose is to identify, train, and help place indigenous and communities of color on publicly appointed boards and commissions in support of an equity agenda. One of the key issues we focus on in the BCLI is housing and my experience on the board has helped me better train my fellows on this topic.

In my first term on the board, I learned a tremendous amount of information about the financing and production of housing as well as its connections to workforce, health, and education issues. I have offered feedback on our annual housing RFP guidelines and other policies. In addition to this, in 2018 Governor Dayton appointed me as the MN Housing exofficio member to the Governor's Task Force on Housing where we created a blueprint to increase the supply of housing and housing services for all Minnesotans. I co-chaired the Home Ownership working group, where we identified the need to incorporate new technologies, building up the housing workforce and the various fees impacting housing production. The blueprint serves as the basis for our new MN Housing strategic plan.

I look forward to continuing my advocacy on the MN Housing board, especially bringing the voices of those most impacted by the housing policies we are proposing and refining. I am disappointed by the fact that home ownership disparities are increasing (a reverse trend) amongst Minnesota's communities of color and the White population and want to continue to focus on this topic along with ending homelessness. I would be honored to be appointed to a second term to work on these goals. I also have volunteered to serve as vice-chair and if reappointed, look forward to chairing this powerful board.
