Dear Governor Walz and Lt. Governor Flanagan:

I am writing in application for appointment to the Minnesota Campaign Finance and Public Disclosure Board. I believe that I am qualified to serve on the Board and would be a fair and effective Board member.

I submit my resume and offer the following information in support of my application.

- I have been involved in politics, campaigns and elections in Minnesota for over 50 years. As a 17-year old high school student in Moorhead, I was elected a Precinct Delegate at my first precinct caucus. When I attended Moorhead State University, my Republican committee colleagues selected me to serve as Chair of the Clay County Republican Party. I was also elected an Alternate Delegate to the 1976 Republican National Convention. When I returned to Minnesota from law school in 1979, I served as Minnesota Coordinator of Congressman John Anderson's campaign for President. Since then, I have worked on countless campaigns for city, county, congressional, state and national candidates.
- In recent years, much of my political work has been to assist Minnesota judges running to retain their seats in elections. I have chaired several campaigns for Supreme Court justices. In each election year since 2004, I have presented a class to judges and their supporters on how to run a judicial campaign. Part of this class focuses on campaign finance laws and reporting. While I am not an expert on this topic, I have a good working knowledge of Minnesota's campaign finance laws.
- I am experienced in the role of campaign treasurers. I served as Treasurer in Tammy Lee's campaign for 5th District Congress (2006) and for City Council Member Linea Palmisano, 13th Ward, Minneapolis (2014-2021). While these campaigns were not regulated by the Board, I became familiar with screening contributions and reporting requirements.
- As a lawyer, I have represented candidates and political party units in campaign and election matters.
- As a proud Member of the White Earth Nation, I have served as Judge of the Tribal Court of Appeals since 2012. I also serve on the appellate courts for the Fond du Lac Band of Lake

Superior Chippewa, Prairie Island Indian Community, and Lower Sioux Indian Community. When a case is appealed, I confer with my fellow judges and we work together to decide the appeal according to the Tribe's laws. I have also worked collegially with board colleagues in many other contexts.

Politically, I would describe myself as an independent. I have not been a public official, held any political party office, or been elected to public office for which party designation is required in the last three years (and longer).

I have great respect for political candidates and public servants and the people who work on or support their campaigns. I believe strongly in First Amendment freedoms and a vigorous and healthy exchange of ideas in political campaigns and policymaking. And my entire career has been based on strong support for the rule of law.

I believe that I could be fair to all Minnesotans – regardless of party, philosophy, or background. In my decision-making duties, I would listen respectfully to the parties' presentations, keep an open mind in discussing the matters with Board staff and members, and decide the issues fairly and impartially according to the law.
