State Procurement Innovation and Participation

\$1.9M in FY23 and \$400K ongoing

- State Match for Procurement Technical Assistance Center (PTAC)
 - Technical and marketing assistance to all Minnesota businesses who want to sell their products and services to government agencies
 - U.S. Department of Defense funds 65% of PTAC costs and this recommendation will cover the remaining 35%
- Updated Procurement Disparity Study
 - Necessary to continue the state's targeted group business programs for woman and minority-owned small businesses



Improving HR and Financial Services

\$301K in FY23 and \$198K ongoing

- Improve Admin's human resources and financial services delivery
- Accommodate Small Agency Resource Team (SmART) Partners
 - Demands have increased for SmART
 - Feasibility study for an Office of Small Agencies



Addressing Revenue Loss in Fleet Fund

\$630K in FY23

Stabilizing the Fleet Fund

 Less fleet usage due to increased telework will cause lower revenue and temporarily result in a deficit in the Fleet Fund



Improving Grants Administration Oversight

\$400K in FY23 and ongoing

- Enhanced Training and Data Analysis in the Office of Grants Management (OGM)
 - OGM would provide greater policy guidance for agencies
 - Greater outreach to partner organizations
- Allow agencies to retain funds for oversight and customer service
 - Ensure compliance with state law



Fostering Collaboration and Resolving Disputes

\$150K in FY23 and ongoing

- Support for the Office of Collaboration and Dispute Resolution (OCDR)
 - Demand for OCDR services exceeds current capacity
 - Funds would provide additional capacity to help state and local governments solve difficult problems



Field Archaeology and Private Cemeteries Act Update

\$200K in FY23 and ongoing

- Office of the State Archaeologist (OSA)
 - Modernizes terminology and clarifies the authority for cemetery condition assessments
 - Requires OSA to do additional condition assessments and keep a database of all known or suspected cemeteries



Eliminating Open Meeting Law Opinion Fees

(\$1K) revenue loss in FY23 and ongoing

Advisory Opinion Consistency

- Eliminates \$200 fee for Open
 Meeting Law advisory opinions
- Comparable Data Practices advisory opinions requests are currently free



Enterprise Language Access Services

\$1.306M in FY23 and \$1.159M ongoing

State Agency Translations

- Provide translation services for written public documents
- Develop and implement best practices for translating public materials
- Enterprise fund for agencies to access for additional translation services or technical expertise
- Language-specific links to translated material on state websites
