

#### **Board of Cosmetology Licensing**

Report Released on May 27, 2021

Presentation to Senate Committee on State Government Finance and Policy and Elections on March 2, 2022

#### **Key findings**

- Complex licensing structure creates unnecessary burdens for licensees
- Confusion about differences between cosmetology and barbering; regulatory inconsistencies

#### Cosmetology


...personal services, for compensation, for the cosmetic care of the hair, nails and skin.

#### **Regulatory Purpose**

- To protect public health and safety
- License required




## The Board of Cosmetology regulates the practice of cosmetology

- Licenses, inspects, enforces
- Received \$2.9 million in FY 2020
- Collects licensing fees and enforcement penalties

#### 7-Member Board

- 2 Cosmetologists
- 1 Esthetician
- 1 Nail technician
- 2 Instructors
- 1 Member of the public



#### Licensing Structure for Practitioners



I hold **five licenses**, which cost approximately \$725 every three years to renew...along with an additional \$1,500+ in continuing education costs...

#### **Operator**

- Complete training and pass practical skills test
- Pass written practical, general theory, and state cosmetology laws exams
- Pay \$195, three-year license fee

#### Salon Manager

- Able to serve as the "designated licensed salon manager" (DLSM)
- 2,700-hour requirement repealed
- Tested on same legal provisions as operators

#### Instructor and School Manager

<b>Level of Practice</b>	Supersedes	Must Also Hold

#### Instructor and School Manager

- Requirements exceed those of underlying licenses, but do not supersede underlying licenses
- Must hold multiple licenses

## Instructor and School Manager Recommendations

 Allow instructor and school manager licenses to supersede underlying licenses



#### **Specialty Licenses**

I feel a separate 'hair' track should be considered for licensing people instead of making students pick cosmetology when they have no desire to do skin or nails.

#### **Specialty Licenses Recommendations**


- Create a hair-only specialty license
- Consider creating other narrow-scope specialty licenses
- Consider endorsement-based licensing structure

Example of Endorsement-Based License

- ☑ Hair
- **☑** Nails
- **☑** Nails Instructor

#### **Salon License**

- Rule change made requirements the same
- Began issuing single type of salon license in 2018
- Statutes still require salon licenses to be differentiated by area of practice



#### Salon License Recommendation

 Allow the board to issue salon licenses that are not differentiated by area of practice



#### **Practice Outside of Salons**

	Homebound Services	Special Event Services
Scope of Practice	Any services	Hairstyling (no cuts or chemical treatments) Makeup Nail polish
Requirements	Must hold any license	Must hold salon manager license  Must notify board where services will be performed
Fee	\$50 for 3 years	\$75 for 1 year

## Practice Outside of Salons Recommendations

- Reevaluate the scope and requirements for these permits
- Consider merging them

#### **Makeup and Hairstyling**

- 2020 Legislation exempted makeup artists and hairstylists from licensing if they take a one-time, four-hour course
- No means to enforce



#### Makeup and Hairstyling Recommendations

- Require unlicensed makeup artists and hairstylists to register
- Publish and audit registrations
- Require makeup artists and hairstylists to take the four-hour course at a regular interval

Credential Required	License	Registration
Manager License	Required	Not required
Practice outside credentialed establishment	Allowed	Not allowed
Mobile establishment	Allowed	Not allowed
Continuing education	Required	Not required
Renewal	\$115, 3-year renewal	\$80, annual renewal

### **Cosmetology and Barbering in Other States**

- Allow only barbers to shave and trim beards
- Allow both barbers and cosmetologists to shave and trim beards
- Offer a crossover license or reciprocity across licenses

## Cosmetology and Barbering Recommendations

- Consider merging the two boards
- Clarify the scopes of practice of cosmetology and barbering
- Allow cosmetology practitioners to count some of their training toward a barber credential and vice versa
