Minnesota Statutes 2020, section 168.33, subdivision 7, is amended to read: 1.14 Subd. 7. Filing fees; allocations. (a) In addition to all other statutory fees and taxes, a 1.15 filing fee of: 1.16 (1) \$7 is imposed on every vehicle registration renewal, excluding pro rate transactions; 1.17 and 1.18 (2) \$11 is imposed on every other type of vehicle transaction, including motor carrier 1.19 fuel licenses under sections 168D.05 and 168D.06, and pro rate transactions. 1.20

(g) An application for a Minnesota identification card, instruction permit, provisional license, or driver's license, including an application for renewal, must contain a provision that allows the applicant to add to the fee under paragraph (a), a \$2 donation for the purposes of public information and education on anatomical gifts under section 171.075.

Subd. 4. **Fee**; **equipment.** (a) The agent may charge and retain a filing fee of \$8 for each application- as follows:

1	(1) New application for noncompliant driver's license	<u>\$</u>	11.00
2	(2) New application for REAL ID compliant driver's license or enhanced driver's license	<u>\$</u>	16.00
4 5	(3) Renewal application for REAL ID compliant driver's license, noncompliant driver's license, or enhanced driver's license	<u>\$</u>	11.00

Except as provided in paragraph (c), the fee shall must cover all expenses involved in receiving, accepting, or forwarding to the department the applications and fees required under sections 171.02, subdivision 3; 171.06, subdivisions 2 and 2a; and 171.07, subdivisions 3 and 3a.

- (b) The statutory fees and the filing fees imposed under paragraph (a) may be paid by credit card or debit card. The driver's license agent may collect a convenience fee on the statutory fees and filing fees not greater than the cost of processing a credit card or debit card transaction. The convenience fee must be used to pay the cost of processing credit card and debit card transactions. The commissioner shall must adopt rules to administer this paragraph using the exempt procedures of section 14.386, except that section 14.386, paragraph (b), does not apply.
- (c) The department shall must maintain the photo identification equipment for all agents 5.27 appointed as of January 1, 2000. Upon the retirement, resignation, death, or discontinuance 5.28 of an existing agent, and if a new agent is appointed in an existing office pursuant to 5.29 Minnesota Rules, chapter 7404, and notwithstanding the above or Minnesota Rules, part 5.30 7404.0400, the department shall must provide and maintain photo identification equipment 5.31 without additional cost to a newly appointed agent in that office if the office was provided 5.32 the equipment by the department before January 1, 2000. All photo identification equipment 5.33 must be compatible with standards established by the department. 5.34

(d) A filing fee retained by the agent employed by a county board must be paid into the county treasury and credited to the general revenue fund of the county. An agent who is not an employee of the county shall must retain the filing fee in lieu of county employment or salary and is considered an independent contractor for pension purposes, coverage under the Minnesota State Retirement System, or membership in the Public Employees Retirement Association.

- (e) Before the end of the first working day following the final day of the reporting period established by the department, the agent must forward to the department all applications and fees collected during the reporting period except as provided in paragraph (d).
- 6.10 **EFFECTIVE DATE.** This section is effective August 1, 2022, and applies to applications made on or after that date.
- Sec. 6. Minnesota Statutes 2020, section 299A.705, is amended by adding a subdivision to read:
  - Subd. 3a. Full-service provider account. (a) The full-service provider account is created in the special revenue fund, consisting of fees described in sections 168.33, subdivision 7, and 171.06, subdivision 2, and any other money donated, allotted, transferred, or otherwise provided to the account.
  - (b) Money in the account is annually appropriated to the commissioner of public safety to distribute to full-service providers, as defined in section 168.002, subdivision 12a. At least quarterly, the commissioner must distribute the money in the account to each full-service provider that was in operation during that quarter based proportionally on the number of transactions completed by each full-service provider.
