1.6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.7	Section 1. Minnesota Statutes 2020, section 171.02, subdivision 3, is amended to read:
1.8	Subd. 3. Motorized bicycle. (a) A motorized bicycle may not be operated on any public
1.9	roadway by any person who does not possess a valid driver's license, unless the person has
1.10	obtained a motorized bicycle operator's permit or motorized bicycle instruction permit from
1.11	the commissioner of public safety. The operator's permit may be issued to any person who
1.12	has attained the age of 15 years and who has passed the examination prescribed by the
1.13	commissioner. The instruction permit may be issued to any person who has attained the age
1.14	of 15 years and who has successfully completed an approved safety course and passed the
1.15	written portion of the examination prescribed by the commissioner.
1.16	(b) This course must consist of, but is not limited to, a basic understanding of:
1.17	(1) motorized bicycles and their limitations;
1.18	(2) motorized bicycle laws and rules;
1.19	(3) safe operating practices and basic operating techniques;
1.20	(4) helmets and protective clothing;
1.21	(5) motorized bicycle traffic strategies; and
1.22	(6) effects of alcohol and drugs on motorized bicycle operators.

2.1	(c) The commissioner may adopt rules prescribing the content of the safety course,
2.2	examination, and the information to be contained on the permits. A person operating a
2.3	motorized bicycle under a motorized bicycle permit is subject to the restrictions imposed
2.4	by section 169.974, subdivision 2, on operation of a motorcycle under a two-wheel instruction
2.5	permit.
2.6	(d) The fees for motorized bicycle operator's permits are as follows:
2.7 2.8	 (1) Motorized bicycle operator's permit before age 21 and valid until \$ 9.75 age 21
2.9	(2) Renewal permit age 21 or older and valid for <u>four eight</u> years \$ 15.75
2.10	(3) Duplicate of any renewal permit \$ 5.25
2.11	(4) Written examination and instruction permit, valid for 30 days \$ 6.75

2.16	Subd. 4. Identification card expiration. (a) Except as otherwise provided in this
2.17	subdivision, the expiration date of a Minnesota identification card is the birthday of the
2.18	applicant in the fourth eighth year following the date of issuance of the card.
2.19	(b) For an applicant age 65 or older:
2.20	(1) the expiration date of a Minnesota identification card is the birthday of the applicant
2.21	in the eighth year following the date of issuance of the card; or
2.22	(2) a noncompliant identification card is valid for the lifetime of the applicant.
2.23	(c) For the purposes of paragraph (b), "Minnesota identification card" does not include
2.24	an enhanced identification card issued to an applicant age 65 or older.
2.25	(d) (b) The expiration date for an Under-21 identification card is the cardholder's 21st
2.26	birthday. The commissioner shall must issue an identification card to a holder of an Under-21
2.27	identification card who applies for the card, pays the required fee, and presents proof of
2.28	identity and age, unless the commissioner determines that the applicant is not qualified for
2.29	the identification card.
2.30	(e) (c) Notwithstanding paragraphs (a) to (d) and (b), the expiration date for an
2.31	identification card issued to a person with temporary lawful status is the last day of the

3.2 person's legal stay is not identified.

Subd. 4. Variance for homebound individuals. (a) Notwithstanding section 171.07 or 3.8 Minnesota Rules, part 7410.1810, the commissioner may grant a variance from the 3.9 photograph requirements for a noncompliant identification card if: (1) the individual is 3.10 homebound as defined in paragraph (b); (2) the individual has submitted proof of homebound 3.11 status; and (3) the department has a photograph of the applicant on file that was taken within 3.12 the last four eight years or during the most recent renewal cycle or the applicant has submitted 3.13 a photograph to the department that meets the requirements of section 171.07, Minnesota 3.14 Rules, part 7410.1810, subpart 1, and other technical requirements established by the 3.15 commissioner, such as background color and electronic file size, to ensure the image can 3.16 be used on a credential and conforms with images taken by the department. Applicants 3.17 granted a photograph variance under this subdivision are not required to appear in person 3.18 to have a new photograph taken. 3.19

3.20 (b) For purposes of this subdivision, "homebound" means the individual is unable to
3.21 leave the individual's residence due to a medical, physical, or mental health condition or
3.22 infirmity as documented in writing by a physician, case worker, or social worker.

(a) Except as otherwise provided in this section, the expiration 3.29 date for each driver's license is the birthday of the driver in the <u>fourth eighth</u> year following 3.30 the date of issuance of the license. The birthday of the driver <u>shall must</u> be as indicated on 3.31 the application for a driver's license. A license may be renewed on or before expiration or 3.32 within one year after expiration upon application, payment of the required fee, and passing 3.33 the examination required of all drivers for renewal. Driving privileges shall must be extended

4.1	or renewed on or preceding the expiration date of an existing driver's license unless the
4.2	commissioner believes that the licensee is no longer qualified as a driver.
4.3	(b) The expiration date for each under-21 license shall must be the 21st birthday of the
4.4	licensee. Upon the licensee attaining the age of 21 and upon the application, payment of
4.5	the required fee, and passing the examination required of all drivers for renewal, a driver's
4.6	license shall must be issued unless the commissioner determines that the licensee is no
4.7	longer qualified as a driver.
4.8	(c) The expiration date for each provisional license is two years after the date of
4.9	application for the provisional license.
4.10	(d) Notwithstanding paragraphs (a) to (c), the expiration date for a license issued to a
4.11	person with temporary lawful status is the last day of the person's legal stay in the United
4.12	States, or one year after issuance if the last day of the person's legal stay is not identified.
