1.5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.6	Section 1. [168.1258] MINNESOTA VIKINGS FOUNDATION SPECIAL PLATES.
1.7	Subdivision 1. Issuance of plates. The commissioner must issue Minnesota Vikings
1.8	Foundation special plates or a single motorcycle plate to an applicant who:
1.9	(1) is a registered owner of a passenger automobile, noncommercial one-ton pickup
1.10	truck, motorcycle, or recreational vehicle;
1.11	(2) pays an additional fee in the amount specified for special plates under section 168.12,
1.12	subdivision 5;
1.13	(3) pays the registration tax as required under section 168.013;
1.14	(4) pays the fees required under this chapter;
1.15	(5) contributes a minimum of \$30 annually to the Minnesota Vikings Foundation account;

2.1	Subd. 3. Plates transfer. On application to the commissioner and payment of a transfer
2.2	fee of \$5, special plates issued under this section may be transferred to another motor vehicle
2.3	if the subsequent vehicle is:
2.4	(1) qualified under subdivision 1, clause (1), to bear the special plates; and
2.5	(2) registered to the same individual to whom the special plates were originally issued.
2.6	Subd. 4. Contributions; account; appropriation. Contributions collected under
2.7	subdivision 1, clause (5), must be deposited in the Minnesota Vikings Foundation account,
2.8	which is established in the special revenue fund. Money in the account is appropriated to
2.9	the commissioner of public safety. This appropriation is first for the annual cost of
2.10	administering the account funds, and the remaining funds are for distribution to the Minnesota
2.11	Vikings Foundation to advance the well-being of youth through engaging health and
2.12	education initiatives.
2.13	EFFECTIVE DATE. This section is effective January 1, 2023, for Minnesota Vikings
2.14	Foundation special plates issued on or after that date.
