

1.1 Senator moves to amend the delete-everything amendment (SCS1154A-9)
1.2 to S.F. No. 1154 as follows:

1.3 Page 2, after line 27, insert:

1.4 "Subd. 2. Administration and Related Services -0- 1,000,000

1.5 This appropriation is from the general fund
1.6 for expanded eligibility for death benefits for
1.7 families of first responders under Minnesota
1.8 Statutes, section 299A.41."

1.9 Renumber the subdivisions in sequence

1.10 Page 44, after line 13, insert:

1.11 "Sec. 23. Minnesota Statutes 2020, section 299A.41, subdivision 3, is amended to read:

1.12 Subd. 3. **Killed in the line of duty.** "Killed in the line of duty" does not include deaths
1.13 from natural causes, except as provided in this subdivision. In the case of a public safety
1.14 officer, killed in the line of duty includes the death of a public safety officer caused by
1.15 accidental means while the public safety officer is acting in the course and scope of duties
1.16 as a public safety officer. Killed in the line of duty also means if a public safety officer dies
1.17 as the direct and proximate result of a heart attack, stroke, or vascular rupture, that officer
1.18 shall be presumed to have died as the direct and proximate result of a personal injury
1.19 sustained in the line of duty if:

1.20 (1) that officer, while on duty:

1.21 (i) engaged in a situation, and that engagement involved nonroutine stressful or strenuous
1.22 physical law enforcement, fire suppression, rescue, hazardous material response, emergency
1.23 medical services, prison security, disaster relief, or other emergency response activity; or

1.24 (ii) participated in a training exercise, and that participation involved nonroutine stressful
1.25 or strenuous physical activity;

1.26 (2) that officer died as a result of a heart attack, stroke, or vascular rupture suffered:

1.27 (i) while engaging or participating under clause (1);

1.28 (ii) while still on duty after engaging or participating under clause (1); or

1.29 (iii) not later than 24 hours after engaging or participating under clause (1); ~~and~~

2.1 (3) that officer died as a result of a disabling cancer of a type caused by exposure to
2.2 heat, radiation, or a known or suspected carcinogen, as defined by the International Agency
2.3 for Research on Cancer, and the carcinogen is reasonably linked to the disabling cancer;

2.4 (4) that officer died due to suicide secondary to a diagnosis of post-traumatic stress
2.5 disorder as described in the most recently published edition of the Diagnostic and Statistical
2.6 Manual of Mental Disorders by the American Psychiatric Association; and

2.7 ~~(3)~~ (5) the presumption is not overcome by competent medical evidence to the contrary."
