

1.1 **Senator Benson from the Committee on Human Services Licensing Policy, to which**
1.2 **was referred**

1.3 **S.F. No. 3583:** A bill for an act relating to human services; modifying various provisions
1.4 relating to substance use disorder treatment; amending Minnesota Statutes 2020, sections
1.5 148F.11, by adding a subdivision; 245A.19; 245F.04, subdivision 1; 245G.01, by adding a
1.6 subdivision; 245G.06, subdivision 3, by adding subdivisions; 245G.07, by adding
1.7 subdivisions; 245G.12.

1.8 Reports the same back with the recommendation that the bill be amended as follows:

1.9 Page 1, line 18, strike "CHEMICAL DEPENDENCY" and insert "SUBSTANCE USE
1.10 DISORDER"

1.11 Page 1, line 20, strike "chemical dependency" and insert "substance use disorder"

1.12 Page 2, lines 1 and 4, strike "chemical dependency" and insert "substance use disorder"

1.13 Page 2, line 30, delete "direction" and insert "direct observation"

1.14 Page 3, line 3, after "The" insert "license holder must ensure that the"

1.15 Page 3, line 4, delete "must document" and insert "documents"

1.16 Page 3, lines 11 and 14, delete "business"

1.17 Page 4, line 4, before "A" insert "(a)"

1.18 Page 4, line 19, reinstate the stricken language and strike "(d)" and insert "(b)"

1.19 Page 4, lines 20 and 21, reinstate the stricken language

1.20 Page 4, lines 25 and 28, delete "services" and insert "counseling"

1.21 Page 5, line 7, delete everything after "provider" and insert "is not required to conduct
1.22 a new comprehensive assessment and is not required to open or reopen a treatment plan or
1.23 document a review of all treatment services"

1.24 Page 5, line 8, delete "progress notes"

1.25 Page 6, after line 5, insert:

1.26 "(e) Recipients who do not have any transportation needs for a medically necessary
1.27 service in a given month or who have received a transit pass for that month through another
1.28 program administered by a county or Tribe are not eligible for a transit pass that month.

1.29 (f) This coordination of transition services is available to a person no more than one
1.30 time each year."

1.31 Page 6, line 30, delete "direction" and insert "direct observation"

2.1 And when so amended the bill do pass and be re-referred to the Committee on Human
 2.2 Services Reform Finance and Policy. Amendments adopted. Report adopted.
