1.22 subdivision 2, paragraphs (b) and (c), in the following statutory sections: Minnesota Statutes,
1.23 sections 245C.15, subdivision 1, paragraph (a), and subdivision 4a, paragraph (a); 609.902,
1.24 subdivision 4; and 626A.05, subdivision 2, clause (1).

1.25 (e) Consistent with paragraphs (a) to (d), the revisor may make technical and other
1.26 necessary changes to language, grammar, and sentence structure in the statutory sections
1.27 listed in this section to preserve the meaning of the text."
