Bill Description

The proposed legislation would extend the term of imprisonment for individuals committed to the commissioner of corrections from two-thirds of their executed sentence to three-fourths of their executed sentence.

Assumptions

It is assumed the provisions of this bill would apply to people admitted to a state correctional facility as a new commit.

DOC planning staff estimate the provisions of this bill would result in the eventual need for 884 additional prison beds each year. The estimated year-by-year prison bed impact would be an additional 42 beds in FY2023, 130 beds in FY2024 and 261 beds in FY2025, eventually reaching 884 beds in FY2032 and each subsequent year.

The impact on supervision caseloads statewide is not expected to be significant as the same number of individuals would eventually be placed on an appropriate level of supervision after a short delay.

Prison bed costs are based on a marginal per diem cost of \$41.80 fpr FY2023, \$42.42 for FY2024, and \$43.18 for FY2025 and each subsequent year. This includes marginal costs for all facility, private and public bed rental, health care and support costs.

The annual costs are estimated by multiplying the number of prison beds by thtee subsequent annual per diem. Unless otherwise noted, prison beds are phased out on a quarterly basis.

Prison bed FTE impact for the increase in the offender population assumes 80 percent of the ongoing bed impact is personnel-related and the average salary per FTE is \$72,000 including benefits.

This bill would be effective August 1, 2022 and apply to persons sentenced on or after that date...

Long-Term Fiscal Considerations

Costs would increase each year, reaching \$13,932,000 in FY2033 and each subsequent year.

This fiscal note assumes use of operating capacity pre-COVID. Costs would be higher in the long-term if the incarcerated population meets or exceeds a capacity level where the DOC would need to rent beds from local corrections agencies. This would occur if there is a need to limit capacity due to social distancing and other pandemic protocols, or if full capacity is reached due to a higher number of total people serving a prison sentence.

Local Fiscal Impact

The impact on local correctional resurces as a result of this bill would be minimal.
