The Hometown Heroes Assistance Program (HHAP) dedicates \$4 million per year to ensure that every Minnesota firefighter has access to the education, prevention and care needed to handle a cardiac, emotional trauma or cancer diagnosis.

## Now, we need your help once again to ensure the program is running as smoothly as possible. Please PASS HF 2746 (Youakim)/SF 2634 (Howe).

The HHAP is a landmark piece of firefighter well-being legislation overwhelmingly supported by a bi-partisan legislature in 2021. Since implementation, it's clear that two small procedural changes are needed to ensure effective administration of the program:

SF 2634 outlines those changes:

- 1. Clarifies that the HHAP applies to diagnosis on or after the effective date of the bill, August 1, 2021. This ensures the funding remains sustainable for its intended duration.
- Changes the flow of funds from the Office of Justice Programs to the State Fire Marshal, which was the intended agency to oversee the funds all along.
- 3. Other minor language clean-up

#### Since 2016, the <u>Minnesota Firefighter Initiative</u> (MnFIRE) has been focused on improving the health crisis in our fire service.

The Hometown Heroes Assistance Program represents a critical part of the solution. The program, which Minnesota legislators passed in 2021, dedicates \$4 million per year to ensure that every Minnesota firefighter will have access to the education, prevention and care needed to handle a cardiac, emotional trauma or cancer diagnosis.

This is the most comprehensive firefighter well-being legislation in the nation, combining three vital resources that are currently available to all active volunteer, paid-on-call, part-time and fulltime Minnesota firefighters for free:

- MnFIRE Assistance Program with expanded emotional trauma resources
- Up-to-\$20,000 critical illness insurance policy
- Ongoing health and wellness training

Thanks to the passage of the Hometown Heroes Assistance Program, we have already:

- Gone live with the programs and received immediate traction as we've rolled out services to volunteer, parttime and career firefighters, including facilitating visits with trauma-informed mental health providers and peer supporters and issuing checks to help firefighters dealing with cancer, cardiac issues, COVID and other critical illnesses.
- Developed and improved training modules, training multiple departments across the state every week.
- Put brochures and other information about the MnFIRE Assistance, critical illness insurance and training programs into the hands of every firefighter in Minnesota.
