- Subdivision 1. The purpose, scope and authority of the housing and redevelopment 2.4 authority established pursuant to this act shall be the same as that provided for under 2.5 Minnesota Statutes, Section 462.415 to 462.7 16, except where inconsistent with subdivision 2.6 2 chapter 469. 2.7
- Subd. 2. HOME IMPROVEMENT LOANS AND GRANTS.
