

1.1 **Senator Pratt from the Committee on Jobs and Economic Growth Finance and**
 1.2 **Policy, to which was re-referred**

1.3 **S.F. No. 3881:** A bill for an act relating to labor and industry; appropriating money for
 1.4 the Department of Labor and Industry; making policy and technical changes; amending
 1.5 Minnesota Statutes 2020, sections 326B.106, subdivision 4; 326B.163, subdivisions 5, 11,
 1.6 12, 13, 15, 16, by adding a subdivision; 326B.164, subdivisions 2, 4; 326B.36, subdivision
 1.7 7, by adding a subdivision; 326B.42, subdivisions 1b, 1c; 326B.437; 326B.46, subdivision
 1.8 2; Minnesota Statutes 2021 Supplement, section 326B.153, subdivision 1; Laws 2021, First
 1.9 Special Session chapter 10, article 3, section 14, subdivision 1.

1.10 Reports the same back with the recommendation that the bill be amended as follows:

1.11 Page 2, line 1, delete "2,505,000" and insert "25,000"

1.12 Page 2, line 4, delete "747,000" and insert "25,000"

1.13 Page 2, delete lines 5 to 10

1.14 Page 2, line 11, delete "747,000" and insert "25,000"

1.15 Page 2, line 12, delete everything before "in" and insert "\$25,000"

1.16 Page 2, line 14, after the period, insert "This is a onetime appropriation."

1.17 Page 2, delete lines 15 to 20

1.18 Page 4, delete lines 29 to 33

1.19 Page 5, delete lines 1 to 6

1.20 Page 6, delete section 3 and insert:

1.21 "Sec. 3. Minnesota Statutes 2020, section 326B.163, subdivision 5, is amended to read:

1.22 Subd. 5. **Elevator.** As used in this chapter, "elevator" means moving walks and vertical
 1.23 transportation devices such as escalators, passenger elevators, freight elevators, dumbwaiters,
 1.24 hand-powered elevators, endless belt lifts, and ~~wheelchair~~ platform lifts. Elevator does not
 1.25 include external temporary material lifts or temporary construction personnel elevators at
 1.26 sites of construction of new or remodeled buildings."

1.27 Page 7, delete section 5 and insert:

1.28 "Sec. 5. Minnesota Statutes 2020, section 326B.164, subdivision 13, is amended to read:

1.29 Subd. 13. **Exemption from licensing.** (a) Employees of a licensed elevator contractor
 1.30 or licensed limited elevator contractor are not required to hold or obtain a license under this
 1.31 section or be provided with direct supervision by a licensed master elevator constructor,
 1.32 licensed limited master elevator constructor, licensed elevator constructor, or licensed limited

2.1 elevator constructor to install, maintain, or repair platform lifts and stairway chairlifts.
 2.2 Unlicensed employees performing elevator work under this exemption must comply with
 2.3 subdivision 5. This exemption does not include the installation, maintenance, repair, or
 2.4 replacement of electrical wiring for elevator equipment.

2.5 (b) Contractors or individuals shall not be required to hold or obtain a license under this
 2.6 section when performing work on:

2.7 (1) conveyors, including vertical reciprocating conveyors;

2.8 (2) platform lifts not covered under section 326B.163, subdivision 5a; or

2.9 (3) dock levelers."

2.10 Page 7, delete sections 6 to 8

2.11 Page 8, delete sections 9 to 10

2.12 Page 9, delete section 11

2.13 Renumber the subdivisions and sections in sequence

2.14 Amend the title numbers accordingly

2.15 And when so amended the bill do pass and be re-referred to the Committee on Finance.
