3845	Utke Lake of the Woods County (excluding city of Baudette)	up to 3%	Fund a new Lake of the Woods County Event and Visitors Bureau for purposes of marketing Lake of the Woods County. This is a special local tax (i.e., not applied to the general sales tax base), so the requirements of sec. 297A.99 do not apply.
4017	Johnson Warren	.5%	Seeks an increase to the amount authorized in 2021 for the construction of a new child care facility. \$2.8 million (increased from \$1.6 million) 35 years (increased from 20 years)
