A resolution relating to ethical conduct; regarding the

conduct of Senator Omar Fateh.

Administration, in response to two complaints submitted by Senators Justin Eichorn, Mark Koran, Mike Goggin, Andrew Mathews, John Jasinski, Scott Newman, and Mark Johnson met on June 8, June 15, July 7, and July 27, 2022, to consider whether the conduct of Senator Omar Fateh in

WHEREAS, the Subcommittee on Ethical Conduct of the Committee on Rules and

regard to campaign promotions provided by Somali TV and the delivery of certain absentee ballots

in the 2020 primary election constituted a violation of Senate Rule 56.3 or 56.4; and

WHEREAS, the Subcommittee on Ethical Conduct makes the following findings:

1. Senator Fatch made payments of \$500.00 on June 20, 2020, and \$500.00 on July 4, 2020,

to Somali TV for placement of campaign ads featuring Senator Fateh on the Somali TV YouTube

channel. Both payments were from his personal accounts.

2. Senator Fateh did not make a concurrent and timely disclosure of the payment for the ads

as a campaign expenditure. Senator Fateh filed an amendment with the Campaign Finance Board

on June 7, 2022, that disclosed the payments described in paragraph 1.

3. Senator Fateh improperly commingled personal and campaign funds to make the payment

for the ads placed on Somali TV.

NOW, THEREFORE,

BE IT RESOLVED by the Subcommittee on Ethical Conduct:

1. The portion of Complaint 1 alleging that Senator Fatch failed to report the value of

advertising on Somali TV is sustained. The subcommittee's findings concerning Senator Fateh's

failure to disclose payments for ads and his commingling of personal and campaign funds must be

addressed by Senator Fateh. Accordingly, Senator Fateh must seek guidance and instruction from

the Campaign Finance and Public Disclosure Board regarding the requirements and best practices

for campaign finance reporting.

2. The portions of Complaint 1 alleging an improper quid pro quo exchange of payment for the

ads on Somali TV in exchange for the introduction of legislation proposing state funding for

Somali TV are dismissed. The remaining portions of Complaint 1 alleging a conflict of interest

are dismissed.

3. Complaint 2 is dismissed in its entirety.

4. Senator Fateh must seek guidance and instruction from the Campaign Finance and Public

Disclosure Board regarding the requirements and best practices for campaign finance reporting.
