



# Governor's MDA Budget Recommendations Bill Walkthrough

March 22, 2023

## Subd.2. Protection Services

- **Soil Health Financial Assistance Program** - \$4,000,000 in FY24-25
- **Pollinator Research Account** - \$100,000 per year ongoing
- **Noxious Weeds Grants** - \$400,000 per year ongoing
- **Grain Indemnity Fund** - \$5,000,000 in FY24
- **Meat Processing Liaison/Navigator** - \$75,000 per year ongoing

# Subd. 3. Ag Marketing and Development

- **International Trade Program Expansion** - \$150,000 per year ongoing
- **Minnesota Grown Program Expansion** – \$75,000 per year ongoing
- **Farm Safety, Health, and Wellness** - \$250,000 per year ongoing
- **Farmers Market Hubs** - \$700,000 in FY24-25 (\$350,000 per year)

# Subd. 4. Ag, Bioenergy, and Biproduct Advancement

- **Expanded Eligibility for Farm to School** – Lines 8.21 – 8.24
- **Bioincentive Program** - \$5,000,000 in FY24-25 and \$10,000,000 in FY26-27
- **Biofuels Infrastructure Grants** - \$1,500,000 per year ongoing
- **Value-Added Entrepreneurial Support** - \$250,000 per year ongoing
- **AGRI Meat Processing** - \$250,000 per year ongoing

# Subd. 5. Administration and Financial Assistance

- **County Fairs Premium Increase** - \$200,000 per year ongoing
- **Pass Through Grants** - \$800,000 in FY24-25
- **Second Harvest Milk Allocation** - \$250,000 per year ongoing
- **Good Acre LEAFF Program** - \$100,000 per year ongoing
- **Services to BIPOC Producers & Businesses** - \$250,000 per year ongoing
- **Emerging Farmers Office Expansion** - \$700,000 (FY24-25) & \$625,000 per year ongoing

## Subd. 5. Continued

- **Ag Emergency Account** - \$1,500,000 in FY24
- **IT Modernization** - \$2,400,000 in FY24-25 (\$1,200,000 each year)
- **Climate Implementation Coordinator** - \$150,000 per year ongoing
- **AgBMP Loan Program Increase** - \$4,000,000 in (FY24-25) & \$3,000,000 per year ongoing
- **Beginning/Emerging Farmers Equipment Grants** - \$200,000 per year ongoing
- **RFA Capacity Increase** - \$150,000 per year ongoing

- **Maintain Service Levels** (throughout Subd) - \$8,055,000 FY24-25 and \$9,288,000 FY26-27
- **NEW GF Ask for FY24-25:** \$44,682,000
- **NEW GF Ask for FY26-27:** \$70,402,000
- **TOTAL:** \$115,084,000

- Fertilizer Tonnage Fee Increase – Line 36.25
- Updated Fee Structure for Nursery Certificates – Lines 37.6 – 43.21
