
Prioritizes students in poverty to address achievement gap

- Statewide grants help local entities construct new, or renovate substandard, early childhood facilities.
- Funds awarded via competitive RFP process.
- Local service providers can create more equitable access and age-appropriate, highquality services to more young children and families with low incomes.

Early Childhood Facilities state bond funded sites:

- **2000-2014**

- 18 sites in 7-county metro
- 57 sites in Greater Minnesota
- 75 total sites

Priority 4: St. Peter Water and Sewer Upgrades

Priority 4: St. Peter Water and Sewer Upgrades

General Obligation \$12.47 M

Future system failure is very likely

- Replaces water mains, sanitary and storm sewers throughout the entire campus.
- The majority of the systems were constructed in the 1950s and have far exceeded their useful life.
- Project was submitted for ARP funding.





Priority 5: Energy System Upgrades

Priority 5: Energy System Upgrades

General Fund \$11.18M

Reduces costs, addresses climate change

- DCT facilities operate continuously requiring substantial energy consumption at peak rates.
- Current annual electric costs at all DCT facilities exceed \$2.68 million
- Adding renewable energy systems will nearly eliminate electrical costs and aligns with goals for a net zero carbon footprint.






Priority 6: Emergency Shelter Facilities Grants

- Acquire property, design, construct, or renovate, furnish and equip facilities for emergency shelters for families and individuals.
- Improves safety, sanitation and livability of existing emergency shelters.







Priority 7: Asset Preservation

Priority 7: Asset Preservation

- Health, safety and code compliance
- Fire sprinkling, detection and alarm systems
- Major mechanical and electrical utility systems
- Sewer and water infrastructure
- Abatement of hazardous materials
- Roof repair and replacement and structural deficiencies
- Tuck pointing, window and door replacement, fascia, soffit and foundation work
- Road, walkway and parking lot repair, replacement and maintenance






Priority 8: Demolition of Johnson Hall

Priority 8: Demolition of Johnson Hall

- Removes a building that is a health and safety hazard on the St. Peter campus.
- The building has been closed for two years.
- Demolition negates more than \$5.6 million in deferred maintenance.







Priority 9: Security Systems

Priority 9: Security System Upgrades

General Fund \$6.49M

Standardizes equipment for safety and security

- DCT's security systems need regular replacement and upgrades.
- Replaces the perimeter fencing and fence monitoring system in Moose Lake.
- Replaces thousands of outdated security cameras and other electronic monitoring tools to enhance the safety and security of our staff, patients, and clients.
