### Capitol Complex Parking Fund Debt Relief

The Governor recommends a permanent waiver of user financing for the repayment of debt service for Ramp F, a parking facility west of the Transportation Building on the Capitol Complex. The impact of this request is \$1,085,227 annually to the general fund in FY 2024 through FY 2034, or about \$12 million over 11 years. This would provide financial relief to the Department of Administration's parking fund.

### Ford Building Demolition Phase I

The Governor recommends \$4.372 million for the demolition of the Ford Building and site work necessary for future development. The Ford Building has been vacant since 2004 and is in critical condition, according to the department's facility condition assessment. This project will address safety hazards and allow the site to be repurposed to meet state facility needs.

### Capital Asset Preservation and Replacement Account (CAPRA)

The Governor recommends \$9 million to fund the Capital Asset Preservation and Replacement Account (CAPRA). This account is for emergency repairs and unanticipated hazardous material abatement needs for state owned facilities.

The Governor recommends \$12 million to expand a revolving loan fund from which the Department of Administration will lend funding to other agencies to finance energy efficiency and water conservation facility improvement projects.

The Governor recommends \$6 million to fund renewable energy investments for state facilities. Agencies would apply for this funding to make improvements to their facilities designed to reduce the energy use and long-term operating costs of the facilities.

The general fund dollars will fund non-bondable asset preservation project costs, including safety and security enhancements. The DOC deferred maintenance backlog is an estimated \$631.3 million.

BDPI is a competitive grant program that provides cities in Greater Minnesota with up to 50% of public infrastructure costs necessary to support economic development. Eligible public infrastructure projects include sewers, streets, wastewater collection and treatment, drinking water, and utility extensions.

### Transportation Economic Development Infrastructure Program (TEDI)

The Governor recommends \$4.8 million for the Transportation Economic Development Infrastructure (TEDI) program. TEDI is a statewide, competitive grant program that provides communities up to 100% of road and public infrastructure project costs to support economic development, private investment, and create jobs. TEDI can be combined with the Minnesota Department of Transportation's Transportation Economic Development (TED) program.

### Innovative Business Development Public Infrastructure Grant Program (IBDPI)

The Governor recommends \$1.2 million for the Innovative Business Development Public Infrastructure (IBDPI) program. IBDPI is a statewide competitive grant program that provides local government units with up to 50% of public infrastructure costs necessary to support economic development in innovative industries. Eligible public infrastructure projects include sewers, streets, utility extensions, land acquisition, and telecommunications.

The Governor recommends authorizing the Minnesota Housing Finance Agency to sell \$250 million in Housing Infrastructure Bonds and recommends a corresponding appropriation of up to \$20 million annually for 20 years from the general fund to pay the debt service on the bonds. Funds will be awarded through competitive request for proposal processes to for-profit developers, non-profit developers, Indian Tribes or tribal housing corporations, and local units of government for supportive housing, preservation, senior housing, single family development, and manufactured home communities. The Governor also recommends expanding the eligible uses of Housing Infrastructure Bonds to include new construction of rental housing for households with incomes at or below 50% of area median income. This amount is in addition to the amount included in the Governor's operating budget.

This project will renovate 63,335 square feet in the Sunrise and Tomlinson building and expand capacity in the program's Community Preparation Services. This additional capacity will allow more individuals to be served in less restrictive settings, allowing DHS to comply with court-ordered transfers out of the secured perimeter and additional clients to participate in reintegration programming.

The Governor also recommends \$413,000 in general fund dollars for program administration.

### Anoka Miller Building Phase I

The Governor recommends \$16.375 million for the Anoka Metro Regional Treatment Center (AMRTC) to remodel the north and south wings of the Miller building. This remodeling will allow this vacant space to be used to serve patients with mental health and/or substance use disorders. This project is Phase I of a multi-phase effort to remodel this building on the AMRTC campus. This phased renovation allows for safety and client service improvements without disrupting operations.

### St. Peter Water and Sewer Upgrades

The Governor recommends \$12.478 million to upgrade and replace the water, sanitary and storm sewer infrastructure at the St. Peter Campus. These systems have exceeded their useful life and their replacement will ensure 1,100 clients and staff have access to functioning and safe water infrastructure.
