

1.1 **Senator Pappas from the Committee on Capital Investment, to which was referred**

1.2 **S.F. No. 667:** A bill for an act relating to capital investment; appropriating money for
1.3 the library construction grant program; authorizing the sale and issuance of state bonds.

1.4 Reports the same back with the recommendation that the bill be amended as follows:

1.10 until the project is completed or abandoned, subject to Minnesota Statutes, section 16A.642.
