- Cross leveraging expertise and resources between Sewa-Aifw and ASU management and staff
- Continue diversifying our experiences with minority members of our community who need culturally specific services and solutions for neurodiverse and senior members

- Help our community grow stronger and resilient, contribute equally to community and to help reduce health, economic, housing, isolation, and racial disparities

We very much look forward to continuing this crucial work with SEWA-AIFW, moving into a neurodiverse and intergenerational future where health and equity are foregrounded and celebrated.
