1.5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.6	Section 1. DAKOTA COUNTY; PEDESTRIAN AND BICYCLE TRAILS.
1.7	Subdivision 1. <b>Appropriation.</b> \$4,380,000 is appropriated from the bond proceeds fund
1.8	to Dakota County for right-of-way acquisition and for design and construction of pedestrian
1.9	safety-related improvements including grade-separated crossings of marked Trunk Highway
1.10	149 in Dakota County. This appropriation includes money for the River to River Greenway
1.11	Crossing.
1.12	Subd. 2. Bond sale. To provide the money appropriated in this section from the bond
1.13	proceeds fund, the commissioner of management and budget shall sell and issue bonds of
1.14	the state in an amount up to \$4,380,000 in the manner, upon the terms, and with the effect
1.15	prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the Minnesota
1.16	Constitution, article XI, sections 4 to 7.
