NDC is proud to provide this letter of support for **Southside Community Health Services (Southside)**. NDC has a 30-year history of developing low-income entrepreneurs through Training, Lending, Technical Assistance, and Incubators. To date, we have trained over 6,370 entrepreneurs and provided over \$32MM in small business loans, primarily to BIPOC business owners. We provide over 4,000 hours of technical assistance annually, and run 5 successful business incubators, including the Midtown Global Market in the heart of South Minneapolis, Frogtown Square, and Frogtown Crossroads at University & Dale.

Given the proximity of Southside's new location to the Midtown Global Market, we know how critical it is to provide this service in the Phillips community.

Southside has been a critical part of South Minneapolis' health care and social services community for over 50 years. Southside currently provides services in two separate facilities located one mile apart, impeding fully integrated care for patients, and space limitations at both locations mean no expansion is possible. The medical clinic is co-located in the Richard R. Green Central Park Elementary School. Southside has not only outgrown the space, but more importantly the facility is not conducive for the delivery of the high-quality healthcare Southside's patients deserve.

Just 36% of all low-income South Minneapolis residents have received care at a community health center, leaving over 56,000 whose needs may be unmet. Southside has a new patient wait list of over 1,000 for dental. Medical and behavioral health provider panels are full. Few local dental providers accept uninsured patients or those covered by Medicaid. There is a significant need for more clinical capacity to serve low-income patients in South Minneapolis. In short, the current facilities do not offer the opportunity to reach thousands more in need and do not match the award-winning quality of care that Southside provides and that its patients deserve. More than 65% of Southside's patients were uninsured in 2022, demonstrating the continued need for clinics like Southside who provide a safety net for the community. Southside serves all regardless of ability to pay and accepts all forms of insurance and other patient assistance programs.

Bringing all services under one roof allows Southside to provide a holistic approach to care, with multi-specialty providers working together to address each patient's unique medical, behavioral health, dental, and vision needs. The increased capacity will allow current patients to receive medical, dental, and behavioral health care in one location.

Southside's mission of *improving the health of our patients and communities by delivering exceptional care, removing barriers, and promoting healthy lifestyles* and the foundational

and historic focus on health equity and expansion of affordable access in the Federally Qualified Health Center program, demonstrates a clear alignment between the State of Minnesota's Health Minnesotans Goals to *prevent future health disparities and to reshape our communities so that everyone will have the opportunity to be healthy.*

Dear Chair Lee and Chair Pappas,

It is our privilege to write to you in support of Southside Community Health Services' new clinic—this is a project that the Lake Street Corridor and south Minneapolis needs now more than ever.

We support Southside's project because the construction of Southside's new 30,000 sq ft clinic space is needed to adequately serve the unmet need for affordable, high quality primary care in the neighborhood. The new facility will:

- bring all of Southside's services (primary medical, dental, vision, and integrated behavioral health) under one roof to better meet the healthcare needs of people served by the clinics.
- provide expanded services to include x-ray, mammography, a diagnostic laboratory, a vision clinic, dental facilities, and community space.
- be open in the evenings and on weekends to provide greater convenience and improved access.
- increase Southside's patient capacity by 40%.
- better meet the community's social determinants of health (food, housing, jobs training, et cetera) by partnering with neighboring social service agencies.
- retain 65 permanent positions (27% LIPs; 80% minority) and create another 28 positions (50% LIPs; 65% minority) in the high wage and high demand healthcare industry.
