1.2 **which was re-referred**

1.3 **S.F. No. 287:** A bill for an act relating to health insurance; establishing supply
1.4 requirements for prescription contraceptives; requiring health plans to cover contraceptive
1.5 methods, sterilization, and related medical services, patient education, and counseling;
1.6 establishing accommodations for eligible organizations; amending Minnesota Statutes 2022,
1.7 section 256B.0625, subdivision 13; proposing coding for new law in Minnesota Statutes,
1.8 chapter 62Q.

1.9 Reports the same back with the recommendation that the bill be amended as follows:

1.15 after "trust" insert ", or similar entity"

1.17 the semicolon, insert "in proportion to their interest held in the corporation, partnership,
1.18 limited liability company, estate, trust, or similar entity"

1.19 Page 2, line 3, delete everything after "by" and insert "all individuals in a family are
1.20 considered held by a single owner."

1.21 Page 2, line 4, delete everything before "For"

1.22 Page 2, line 7, after "option" insert ", warrant, or similar right"

1.23 Page 2, line 12, before the period, insert ", excluding vasectomies"

1.24 Page 2, line 19, delete the second "as a" and insert "out to be" and delete "organization"

1.25 Page 2, line 20, after "organization's" insert "owners or"

1.26 Page 2, line 22, delete "it" and insert "the organization"

1.27 Page 2, after line 24, insert:

1.28 "(f) "Exempt organization" means an organization that is organized and operates as a
1.29 nonprofit entity and meets the requirements of section 6033(a)(3)(A)(i) or (iii) of the Internal
1.30 Revenue Code of 1986, as amended."


