1.2 Delete everything after the enacting clause and insert:

1.3 "Section 1. Minnesota Statutes 2022, section 5B.06, is amended to read:

1.4 **5B.06 VOTING BY PROGRAM PARTICIPANT; ABSENTEE BALLOT.**

1.5 A program participant who is otherwise eligible to vote may register with the secretary
 1.6 of state as a permanent absentee voter. Notwithstanding section 203B.04, subdivision 5,
 1.7 the secretary of state is not required to send an absentee ballot application prior to each
 1.8 election to a program participant registered as a permanent absentee voter under this section.
 1.9 As soon as practicable before each election, the secretary of state shall determine the precinct
 1.10 in which the residential address of ~~the~~ a program participant is located ~~and~~. Upon making
 1.11 a precinct determination, the secretary of state shall either (1) request from and receive from
 1.12 the county auditor or other election official the ballot for that precinct and ~~shall forward~~
 1.13 mail the absentee ballot to the program participant ~~with the other~~, or (2) using the Minnesota
 1.14 statewide voter registration system, prepare the program participant's ballot for that precinct
 1.15 and mail the absentee ballot to the program participant. The secretary of state shall include
 1.16 with each mailed absentee ballot all corresponding materials for absentee balloting as
 1.17 required by Minnesota law. The program participant shall complete the ballot and return it
 1.18 to the secretary of state, who shall review the ballot in the manner provided by section
 1.19 203B.121, subdivision 2. If the ballot and ballot materials comply with the requirements of
 1.20 that section, the ballot must be certified by the secretary of state as the ballot of a program
 1.21 participant, and must be forwarded to the appropriate electoral jurisdiction for tabulation
 1.22 along with all other ballots. The name and address of a program participant must not be
 1.23 listed in the statewide voter registration system.

1.25 Subdivision 1. **Prior to election day.** (a) At any time except during the 20 days
 1.26 immediately preceding any regularly scheduled election, an eligible voter or any individual
 1.27 who will be an eligible voter at the time of the next election may register to vote in the
 1.28 precinct in which the voter maintains residence by completing a voter registration application
 1.29 as described in section 201.071, subdivision 1. A completed application may be submitted:

1.30 (1) in person or by mail to the county auditor of that county or to the Secretary of State's
 1.31 Office; or

2.1 (2) electronically through a secure website that shall be maintained by the secretary of
2.2 state for this purpose, if the applicant has an email address and provides the applicant's
2.3 verifiable Minnesota driver's license number, Minnesota state identification card number,
2.4 or the last four digits of the applicant's Social Security number.

2.5 (b) A registration that is received in person or by mail no later than 5:00 p.m. on the
2.6 21st day preceding any election, or a registration received electronically through the secretary
2.7 of state's secure website no later than 11:59 p.m. on the 21st day preceding any election,
2.8 shall be accepted. An improperly addressed or delivered registration application shall be
2.9 forwarded within two working days after receipt to the county auditor of the county where
2.10 the voter maintains residence. A state or local agency or an individual that accepts completed
2.11 voter registration applications from a voter must submit the completed applications to the
2.12 secretary of state or the appropriate county auditor within ten calendar days after the
2.13 applications are dated by the voter.

2.15 be transmitted to the county auditor for processing if the secretary of state has verified the
2.16 application information matches the information in a government database associated with

2.18 number. The secretary of state must review all unverifiable voter registration applications
2.19 submitted electronically for evidence of suspicious activity and must forward any such
2.20 application to an appropriate law enforcement agency for investigation.

2.22 of any other individual, except that the secretary of state may provide features on the secure
2.23 website established under paragraph (a), clause (2), that allow third parties to connect

2.27 application delivered to the secretary of state, county auditor, or municipal clerk by the
2.28 United States Postal Service or a commercial carrier.

2.30 Subd. 3. **Election day registration.** (a) An individual who is eligible to vote may register
2.31 on election day by appearing in person at the polling place for the precinct in which the
2.32 individual maintains residence, by completing a registration application, making an oath in
2.33 the form prescribed by the secretary of state and providing proof of residence. An individual
2.34 may prove residence for purposes of registering by:

3.1 (1) presenting a driver's license or Minnesota identification card issued pursuant to
3.2 section 171.07;

3.3 (2) presenting any document approved by the secretary of state as proper identification;

3.4 (3) presenting one of the following:

3.5 (i) a current valid student identification card from a postsecondary educational institution
3.6 in Minnesota, if a list of students from that institution has been prepared under section
3.7 135A.17 and certified to the county auditor in the manner provided in rules of the secretary
3.8 of state; or

3.9 (ii) a current student fee statement that contains the student's valid address in the precinct
3.10 together with a picture identification card; or

3.11 (4) having a voter who is registered to vote in the precinct, or an employee employed
3.12 by and working in a residential facility in the precinct and vouching for a resident in the
3.13 facility, sign an oath in the presence of the election judge vouching that the voter or employee
3.14 personally knows that the individual is a resident of the precinct. A voter who has been
3.15 vouched for on election day may not sign a proof of residence oath vouching for any other
3.16 individual on that election day. A voter who is registered to vote in the precinct may sign
3.17 up to eight proof-of-residence oaths on any election day. This limitation does not apply to
3.18 an employee of a residential facility described in this clause. The secretary of state shall
3.19 provide a form for election judges to use in recording the number of individuals for whom
3.20 a voter signs proof-of-residence oaths on election day. The form must include space for the
3.21 maximum number of individuals for whom a voter may sign proof-of-residence oaths. For
3.22 each proof-of-residence oath, the form must include a statement that the individual: (i) is
3.23 registered to vote in the precinct or is an employee of a residential facility in the precinct,
3.24 (ii) personally knows that the voter is a resident of the precinct, and (iii) is making the
3.25 statement on oath. The form must include a space for the voter's printed name, signature,
3.26 telephone number, and address.

4.28 Sec. 4. Minnesota Statutes 2022, section 201.071, subdivision 1, is amended to read:

4.29 Subdivision 1. **Form.** Both paper and electronic voter registration applications must
4.30 contain the same information unless otherwise provided by law. A voter registration
4.31 application must contain spaces for the following required information: voter's first name,
4.32 middle name, and last name; voter's previous name, if any; voter's current address; voter's
4.33 previous address, if any; voter's date of birth; voter's municipality and county of residence;
4.34 voter's telephone number, if provided by the voter; date of registration; current and valid

5.1 Minnesota driver's license number or Minnesota state identification number, or if the voter
5.2 has no current and valid Minnesota driver's license or Minnesota state identification, the
5.3 last four digits of the voter's Social Security number; and voter's signature. The paper

5.19 has expired (been completed) or I have been discharged from my sentence; and

5.20 (8) have read and understand the following statement: that giving false information is a
5.21 felony punishable by not more than five years imprisonment or a fine of not more than
5.22 \$10,000, or both."

5.23 The certification must include boxes for the voter to respond to the following questions:

5.24 "(1) Are you a citizen of the United States?" and

5.25 "(2) Will you be 18 years old on or before election day?"

5.26 And the instruction:

5.27 "If you checked 'no' to either of these questions, do not complete this form."

5.28 The form of the voter registration application and the certification of voter eligibility
5.29 must be as provided in this subdivision and approved by the secretary of state. Voter
5.30 registration forms authorized by the National Voter Registration Act must also be accepted

6.1 as valid. The federal postcard application form must also be accepted as valid if it is not
6.2 deficient and the voter is eligible to register in Minnesota.

6.3 An individual may use a voter registration application to apply to register to vote in
6.4 Minnesota or to change information on an existing registration.

6.15 (b) A voter registration application is not deficient due to any of the following:

6.19 (3) the absence of a number listed under paragraph (a), clause (2), if the voter has not

6.21 database associated with the applicant's name and date of birth, or the application was
6.22 accepted before January 1, 2004.

6.27 (c) A voter registration application:

6.28 (1) accepted prior to August 1, 1983, is not deficient for lack of date of birth. The county
6.29 or municipality may attempt to obtain the date of birth for a voter registration application
6.30 accepted prior to August 1, 1983, by a request to the voter at any time except at the polling

7.1 place. Failure by the voter to comply with this request does not make the registration
7.2 deficient; and

7.3 ~~A voter registration application accepted before January 1, 2004, is not deficient for lack~~

7.13 voter's registration application is deficient or the voter's eligibility to vote is successfully
7.14 challenged under section 201.195 or 204C.12.

7.16 Subd. 8. **School district assistance.** School districts shall assist county auditors in
7.17 determining the school district in which a voter ~~resides~~ maintains residence.

7.18 Sec. 7. Minnesota Statutes 2022, section 201.091, subdivision 2, is amended to read:

7.19 Subd. 2. **Corrected list.** By February 15 of each year, the secretary of state shall prepare
7.20 the master list for each county auditor. The records in the statewide registration system must
7.21 be periodically corrected and updated by the county auditor. An updated master list for each
7.22 precinct must be available for absentee voting at least 46 days before each election. A final
7.23 corrected master list must be available ~~seven~~ 14 days before each election.

7.25 Subd. 4a. **Presidential primary political party list.** The secretary of state must maintain

8.2 Subd. 2. **Moved within state.** If any nonforwardable mailing from an election official
8.3 is returned as undeliverable but with a permanent forwarding address in this state, the county
8.4 auditor may change the voter's status to "inactive" in the statewide registration system and
8.5 shall transmit a copy of the mailing to the auditor of the county in which the new address
8.6 is located. If an election is scheduled to occur in the precinct in which the voter ~~resides~~
8.7 maintains residence in the next 47 days, the county auditor shall promptly update the voter's
8.8 address in the statewide voter registration system. If there is not an election scheduled, the
8.9 auditor may wait to update the voter's address until after the next list of address changes is
8.10 received from the secretary of state. Once updated, the county auditor shall mail to the voter

8.19 Subdivision 1. **Entry of registration information.** (a) At the time a voter registration
8.20 application is properly completed, submitted, and received in accordance with sections
8.21 201.061 and 201.071, the county auditor shall enter the information contained on it into the
8.22 statewide registration system. Voter registration applications completed before election day
8.23 must be entered into the statewide registration system within ten days after they have been
8.24 submitted to the county auditor. Voter registration applications completed on election day
8.25 must be entered into the statewide registration system within 42 days after the election,
8.26 unless the county auditor notifies the secretary of state before the deadline has expired that
8.27 the deadline will not be met. Upon receipt of a notification under this paragraph, the secretary
8.28 of state must extend the deadline for that county auditor by an additional 28 days. The
8.29 secretary of state may waive a county's obligations under this paragraph if, on good cause

9.6 (c) Within ten days after the county auditor has entered information from a voter
9.7 registration application into the statewide registration system, the secretary of state shall
9.8 compare the voter's name, date of birth, and driver's license number, state identification
9.9 number, or the last four digits of the Social Security number with the same information

9.11 (d) The secretary of state shall provide a report to the county auditor on a weekly basis

9.15 have submitted a voter registration application by mail and have not voted in a federal

9.21 (f) The county auditor shall send a notice of incomplete registration to any voter whose
9.22 name appears on the list and change the voter's status to "~~incomplete.~~" "challenged." A voter
9.23 who receives a notice of incomplete registration from the county auditor may either provide
9.24 the information required to ~~complete the registration~~ clear the challenge at least 21 days
9.25 before the next election or at the polling place on election day.

9.27 Subd. 3. **Use of change of address system.** (a) At least once each month the secretary
9.28 of state shall obtain a list of individuals registered to vote in this state who have filed with
9.29 the United States Postal Service a change of their permanent address. The secretary of state
9.30 may also periodically obtain a list of individuals with driver's licenses or state identification
9.31 cards to identify those who are registered to vote who have applied to the Department of
9.32 Public Safety for a replacement driver's license or state identification card with a different
9.33 address, and a list of individuals for whom the Department of Public Safety received
9.34 notification of a driver's license or state identification card cancellation due to a change of

10.1 residency out of state. However, the secretary of state shall not load data derived from these
10.2 lists into the statewide voter registration system within the 47 days before the state primary
10.3 or 47 days before a November general election.

10.4 (b) If the address is changed to another address in this state, the secretary of state shall

10.7 secretary must transmit the information about the changed address by electronic means to
10.8 the county auditor of the county in which the new address is located. For addresses for
10.9 which the secretary of state is unable to determine the precinct, the secretary may forward
10.10 information to the appropriate county auditors for individual review. If the voter has not
10.11 voted or submitted a voter registration application since the address change, upon receipt
10.12 of the information, the county auditor shall update the voter's address in the statewide voter
10.13 registration system. The county auditor shall mail to the voter a notice stating the voter's
10.14 name, address, precinct, and polling place, unless the voter's record is challenged due to a
10.15 felony conviction, noncitizenship, name change, incompetence, or a court's revocation of
10.16 voting rights of individuals under guardianship, in which case the auditor must not mail the
10.17 notice. The notice must advise the voter that the voter's voting address has been changed
10.18 and that the voter must notify the county auditor within 21 days if the new address is not
10.19 the voter's address of residence. The notice must state that it must be returned if it is not
10.20 deliverable to the voter at the named address.

10.21 (c) If the change of permanent address is to an address outside this state, the secretary
10.22 of state shall notify by electronic means the auditor of the county where the voter formerly
10.23 ~~resided~~ maintained residence that the voter has moved to another state. If the voter has not
10.24 voted or submitted a voter registration application since the address change, the county
10.25 auditor shall promptly mail to the voter at the voter's new address a notice advising the voter
10.26 that the voter's status in the statewide voter registration system will be changed to "inactive"
10.27 unless the voter notifies the county auditor within 21 days that the voter is retaining the
10.28 former address as the voter's address of residence, except that if the voter's record is
10.29 challenged due to a felony conviction, noncitizenship, name change, incompetence, or a
10.30 court's revocation of voting rights of individuals under guardianship, the auditor must not
10.31 mail the notice. If the notice is not received by the deadline, the county auditor shall change

10.33 (d) If, in order to maintain voter registration records, the secretary of state enters an
10.34 agreement to share information or data with an organization governed exclusively by a
10.35 group of states, the secretary must first determine that the data security protocols are sufficient

11.1 to safeguard the information or data shared. If required by such an agreement, the secretary
11.2 of state may share the following data from the statewide voter registration system and data
11.3 released to the secretary of state under section 171.12, subdivision 7a:

11.4 (1) name;

11.5 (2) date of birth;

11.6 (3) address;

11.7 (4) driver's license or state identification card number;

11.8 (5) the last four digits of an individual's Social Security number; and

11.9 (6) the date that an individual's record was last updated.

11.16 Subdivision 1. **Forms.** All postsecondary institutions that enroll students accepting state
11.17 or federal financial aid shall provide voter registration forms to each student as early as
11.18 possible in the fall quarter. All school districts shall make available voter registration
11.19 applications each May and September to all students registered as students of the school
11.20 district who will be eligible to vote at the next election after those months. A school district
11.21 has no obligation to provide voter registration applications to students who participate in a
11.22 postsecondary education option program or who otherwise ~~reside~~ maintain residence in the
11.23 district but do not attend a school operated by the district. A school district fulfills its
11.24 obligation to a student under this section if it provides a voter registration application to the
11.25 student one time. The forms must contain spaces for the information required in section
11.26 201.071, subdivision 1, and applicable rules of the secretary of state. The institutions and
11.27 school districts may request these forms from the secretary of state. Institutions shall consult
11.28 with their campus student government in determining the most effective means of distributing

12.2 **201.195 CHALLENGES.**

12.3 Subdivision 1. **Petition; hearing timing.** (a) Upon petition filed with the county auditor,
12.4 any voter registered within a county may challenge the eligibility or residence of any other
12.5 voter registered within that county. A challenge filed pursuant to this section must not
12.6 include the name of more than one person whose right to vote is challenged. The county
